WHEREAS, the certificate of authority issued to WASHINGTON CASUALTY COMPANY ("WASHINGTON CASUALTY"), a company domiciled in the state of Washington, licensed for property and casualty insurance in the state of Idaho, has been suspended by the Department of Insurance, state of Idaho by Orders dated March 20, 2003, March 19, 2004, February 10, 2005, and April 26, 2006 pursuant to Idaho Code § 41-327(3) by reason of the company being placed under the supervision of the Insurance Commissioner, and his successors, as statutory Receiver in the state of Washington, for purposes of rehabilitation, by the state of Washington, Thurston County Superior Court, Case No., 03-2-00401-1, pursuant to an Order of Rehabilitation and Appointment of Receiver, dated March 6, 2003; and

ORDER OF REINSTATEMENT OF CERTIFICATE OF AUTHORITY - Page 1

WHEREAS, WASHINGTON CASUALTY has been sold to FinCor Holdings, Inc. and has been released from rehabilitation, as evidenced by information from the website of Washington Office of the Insurance Commissioner as of June 2007 and by the state of Washington, Thurston County Superior Court, Case No, 03-2-00401-1, pursuant to an Order Confirming Closing of the Stock Purchase Agreement, Discharging Receiver and Closing Northwest Healthcare Insurance Services, Inc. and Washington Casualty Company, dated October 6, 2006;

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to the provisions of Idaho Code § 41-329, that Certificate of Authority No. 2722, issued to WASHINGTON CASUALTY, be REINSTATED effective April 27, 2007, the date the most recent suspension order expired.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See Section 67-5246(4), Idaho Code.

Pursuant to Sections 67-5270 and 67-5272, Idaho Code, any party aggrieved by this final order or orders previously issued in this case may appeal this final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho, or
- iv. The real property or personal property that was the subject of the agency action is located.

An appeal must be filed within twenty-eight (28) days (a) of this final order, (b) of an order denying any petition for reconsideration, or (c) the failure within twenty-one (21) days to

grant or deny a petition for reconsideration, whichever is later. See Section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.
