WHEREAS, the Certificate of Authority issued to GREAT REPUBLIC LIFE INSURANCE COMPANY ("GREAT REPUBLIC"), a company domiciled in the state of Washington, licensed for life and disability insurance in the state of Idaho, has been suspended by the Department of Insurance, state of Idaho, by order dated April 3, 2007 pursuant to Idaho Code § 41-326(1)(b) due to the failure of the company to meet the surplus requirements set forth at Idaho Code § 41-313(1); and

WHEREAS, in review of the company's 2007 Third Quarter Financial Statement dated September 30, 2007 GREAT REPUBLIC reported One Million Dollars (\$1,000,000) in common capital stock and a surplus of Two Hundred Seventy-Nine Thousand Eight Hundred Forty-Eight

Dollars (\$279,848), and therefore does not meet the requirements for maintaining surplus set forth at Idaho Code § 41-313, and therefore does not meet the requirements for a certificate of authority in the state of Idaho;

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to provisions of Idaho Code § 41-326(1)(b), that Certificate of Authority No. 1185 issued to GREAT REPUBLIC be CONTINUED in SUSPENSION effective immediately, and that GREAT REPUBLIC comply with each of the requirements of Idaho Code § 41-329, including § 41-329(2) which states: "During the suspension period the insurer shall not solicit or write any new business in this state, but shall file its annual statement, pay fees, licenses, and taxes as required under this code, and may service its business already in force in this state, as if the certificate of authority had continued in full force", and that pursuant to this section, said suspension be continued for a period of one (1) year from the date of this order. The Director may terminate the suspension sooner if the cause for said suspension is terminated and GREAT REPUBLIC is otherwise in compliance with the provisions of Title 41, Idaho Code.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. *See* section 67-5246(4), Idaho Code.

Pursuant to sections 67-5270 and 67-5272, Idaho Code, any party aggrieved by this final order or orders previously issued in this case may appeal this final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

i. A hearing was held

- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho, or
- iv. The real property or personal property that was the subject of the agency action is located.

An appeal must be filed within twenty-eight (28) days (a) of this final order, (b) of an order denying any petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. *See* section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.
