STIPULATION

COMES NOW the Department of Insurance, State of Idaho (Department), by and through its counsel, Michael K. Naethe, Deputy Attorney General, and Pioneer Title Company (PIONEER), by and through Jesse R. Hamilton, General Counsel, and hereby stipulate and agree as follows:

PIONEER is duly licensed as a title company by the State of Idaho, holding 1. license TA 5685 and is therefore subject to the provisions of Title 41, Idaho

- Code, and to the Rules and Regulations of the Department of Insurance promulgated thereunder.
- 2. Prior to August 4, 2007, PIONEER provided a fifty dollar (\$50) gift certificate to three producers of title.
- On or about August 4, 2007, the gift certificate was used without
 PIONEER's knowledge or consent as a door prize during the Hillsdale
 Showcase of Homes.
- 4. PIONEER admits the gift as used constitutes a "prohibited thing of value" in violation of IDAPA 18.01.56.
- 5. On or about December 5 2007, PIONEER agreed to pay an administrative penalty of one hundred fifty dollars (\$150).
- 6. On or about December 5, 2007, the Department received Check #17121 payable to the Department in an amount equal to the aforementioned administrative penalty.
- 7. The Department shall forego administrative action to impose additional penalties for any violations of Title 41, Idaho Code, and the Rules and Regulations of the Department of Insurance promulgated thereunder in regard to the Hillsdale Showcase of Homes door prizes.
- 8. The parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein, and that they have entered into this Stipulation knowingly, voluntarily, and with full knowledge of any rights they may be waiving thereby. Additionally, the

parties hereby waive the right to seek reconsideration and judicial review of the attached order.
