WHEREAS, the Certificate of Authority issued to AMERIN GUARANTY CORPORATION ("AMERIN"), a company domiciled in the state of Illinois, licensed for property and casualty insurance in the state of Idaho, has been suspended by the Department of Insurance, state of Idaho, by an order dated April 8, 2008, pursuant to Idaho Code § 41-326(1)(b) due to the failure of the company to meet the surplus requirements set forth at Idaho Code § 41-313(1); and

WHEREAS, the company's first quarter financial statement filed May 15, 2008, reflects total surplus of Twelve Million Ten Thousand Six Hundred Sixty-six Dollars (\$12,010,666), consisting of Five Million Three Hundred Seven Thousand Four Hundred Fifty-six Dollars (\$5,307,456) and Six Million Seven Hundred Three Thousand Two Hundred Ten Dollars (\$6,703,210) surplus and AMERIN has cured its deficiency and thereby meets the One Million Dollar (\$1,000,000) surplus requirement set forth at Idaho Code § 41-313(1);

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to the provisions of Idaho Code § 41-329, that Certificate of Authority No. 1420, issued to AMERIN, be REINSTATED effective immediately.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See Section 67-5246(4), Idaho Code.

Pursuant to Sections 67-5270 and 67-5272, Idaho Code, any party aggrieved by this final order or orders previously issued in this case may appeal this final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho, or
- iv. The real property or personal property that was the subject of the agency action is located.

An appeal must be filed within twenty-eight (28) days (a) of this final order, (b) of an order denying any petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. See Section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.
