COME NOW the Department of Insurance, State of Idaho (Department), by and through its counsel, Thomas A. Donovan, Deputy Attorney General, and Bristol West Insurance Company (BRISTOL WEST) by and through its undersigned officer and hereby stipulate and agree as follows:

1. BRISTOL WEST is an Ohio domiciled insurer licensed for property and casualty insurance holding Idaho certificate of authority no. 863, and therefore is subject to the Idaho Insurance Code and applicable rules promulgated thereunder as well as to the jurisdiction of the Director.

- 2. On December 13, 2007 BRISTOL WEST filed its Select 2.5 Private Passenger Auto Product (Select 2.5) policy with the Rates and Forms section of the Department.
- 3. On December 19, 2007 the Department submitted an objection letter to BRISTOL WEST concerning the Select 2.5 filing via System for Electronic Rate and Form Filing (SERFF). That objection letter cited three concerns with the Select 2.5 filing asking BRISTOL WEST to respond by January 2, 2008.
- 4. On January 4, 2008 the Department, via SERFF, disapproved the Select 2.5 filing due to lack of response to the objection letter previously sent to BRISTOL WEST.
- 5. BRISTOL WEST submitted a letter to the Department dated June 10, 2008 answering the questions asked in the December 19, 2007 objection letter.
- 6. BRISTOL WEST representatives met with Department staff and the Director on June 12, 2008. In that meeting, BRISTOL WEST voluntarily disclosed to the Department that the company had issued One Thousand Sixty Six (1,066) Select 2.5 policies since January 4, 2008 and had not realized that such policy filing had been disapproved by the Department as of that date.
- 7. BRISTOL WEST agrees that its actions set forth in paragraph 6 violate Idaho Code § 41-1812.
- 8. BRISTOL WEST agrees and stipulates to pay an administrative penalty in the amount of Five Thousand Three Hundred Thirty Dollars (\$5,330.00).
- 9. The parties agree that this stipulation is a reasonable resolution, and BRISTOL WEST and the Department waive their rights to a hearing in this matter and to seek reconsideration and judicial review of the attached order or any substantially similar order.
