WHEREAS, it appears that AMERICAN NETWORK INSURANCE COMPANY ("AMERICAN NETWORK"), a company domiciled in the state of Pennsylvania, licensed for life and disability insurance in the state of Idaho under Certificate of Authority No. 1715 is in an unsound financial condition, pursuant to IDAPA 18.01.66.011.06 as of December 31, 2008, its decrease in surplus is Sixteen Million Four Hundred Thirteen Thousand Four Hundred Sixty-six Dollars (\$16,413,466), which amount is greater than fifty percent (50%) of the remaining surplus as regards policy holders in excess of the statutory minimum, which amount is Four Million Eight Hundred Eight Thousand Three Hundred Ninety-seven Dollars (\$4,808,397); and

WHEREAS, AMERICAN NETWORK was placed into rehabilitation on January 6, 2009 by order of the Commonwealth Court of Pennsylvania, No. 4 M.D. 2009 based on the

Pennsylvania Insurance Commissioner's Petition for Rehabilitation of American Network Insurance Company.

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to the provisions of Idaho Code § 41-327(3), that Certificate of Authority No. 1715, issued to AMERICAN NETWORK be SUSPENDED effective immediately, and that AMERICAN NETWORK comply with each of the requirements of Idaho Code § 41-329, including § 41-329(2) which states: "During the suspension period the insurer shall not solicit or write any new business in this state, but shall file its annual statement, pay fees, licenses, and taxes as required under this code, and may service its business already in force in this state, as if the certificate of authority had continued in full force", and that pursuant to this section, said suspension be continued for a period of one (1) year from the date of this order. The Director may terminate the suspension sooner if the cause for said suspension is terminated and AMERICAN NETWORK is otherwise in compliance with the provisions of Title 41, Idaho Code.

IT IS FURTHER ORDERED, pursuant to the provisions of Idaho Code § 41-330, that AMERICAN NETWORK, within four (4) days after notice of this suspension is received, notify, by any available means, every person authorized to write business by said insurance company in the state of Idaho, to immediately cease any further writing of such business.

IT IS FURTHER ORDERED, that AMERICAN NETWORK promptly return Certificate of Authority No. 1715 to the Idaho Department of Insurance, as required by Idaho Code § 41-323.

IT IS FURTHER ORDERED, that within 60 days of the date of this order AMERICAN NETWORK file with the Director a complete listing of its policies owned by or issued to residents of the State of Idaho. Such list shall include the name and address of each policyholder and insured, policy type, face amount, and cash surrender value of the policy, as applicable.
