SECOND ORDER APPROVING REVISED PLAN AND AMENDMENT

WHEREAS AIPSO, an association of insurers with its principal office in Rhode Island, and holding rating organization license number 2025, has submitted to the Idaho Department of Insurance (the "Department"), pursuant to Idaho Code §§ 41-1420 and 41-1425(2) (concerning rating organizations generally) and § 49-1225 (concerning assigned risk automobile plans), its revised Idaho Automobile Insurance Plan Manual identified as ID 2010 Revision 002 (the "Manual"), with specific amendments thereto identified in AIPSO Filing Nos. ID 10-04 and ID 10-05, which Manual is incorporated herein by reference as though fully set forth;

WHEREAS, the recent amendment to Section 18 of the Manual, as set forth in AIPSO Filing No. ID 10-04, expands the reasons for ineligibility for plan coverage to include failure of

the insured to locate a producer of record when asked to do so by a CAIP (commercial automobile insurance procedure) servicing carrier;

WHEREAS, the recent amendment to Section 31 of the Manual, as set forth in AIPSO Filing No. ID 10-04, adds a new performance standard which requires that the CAIP servicing carrier make at least two written requests to the insured to obtain a new producer of record and, if the insured does not obtain a new producer, that the servicing carrier advise the insured that its plan policy will be non-renewed;

WHEREAS, the recent amendment to Section 35 of the Manual, as set forth in AIPSO Filing No. ID 10-05, clarifies and enhances the requirements for a subscriber company representative serving on the Governing Committee by stating that the subscriber company representative may be a salaried employee or officer of the named subscriber company, a salaried employee or officer of another subscriber company from a group of companies under the same management as the named subscriber company, or a salaried employee or officer of the holding company of the named subscriber company; and addresses the resignation of a subscriber company representative midterm;

WHEREAS, AIPSO desires to confirm written approval of the revised Manual, which will become effective the first day of the second month following approval by the Director of the Idaho Department of Insurance (the "Director"); and

WHEREAS, Department staff, having reviewed said revised Manual and amendments, finding that they are consistent with the Idaho Insurance Code, and concluding that it is in the best interests of AIPSO and plan subscribers, and by submission of this order to the Director the Department, recommends that the Director confirm approval of the Manual with the proposed amendments;

NOW, THEREFORE, based upon the foregoing and good cause appearing therefor,

IT IS HEREBY ORDERED that the revised Manual, identified as ID 2010 Revision 002, including the most recent amendments to Sections 18, 31, and 35 thereof as set forth above, is approved pursuant to Idaho Code § 49-1225 and Chapters 2 and 14 of Title 41, Idaho Code.
