STIPULATION

The parties hereto, namely the Idaho Department of Insurance and the Applicant, Shey D. Pyne, do hereby stipulate and agree as follows:

1. That the Director of the Idaho Department of Insurance has jurisdiction concerning the matters at issue herein in accordance with title 41, Idaho Code.

2. That Shey D. Pyne made application for a resident producer's license on or about October 26, 2010.

3. That said application for a resident producer's license was initially denied in a letter to Mr. Pyne dated November 5, 2010.

4. That Mr. Pyne timely asked for a hearing on his application and said hearing was

held on December 8, 2010 before Hearing Officer David V. Nielsen.

5. That at said hearing and after hearing all of the evidence, the Department made an offer to settle this matter subject to the finding of the Director of the Idaho Department of Insurance that the following arrangement will serve the public good by the issuance of a temporary license pursuant to Idaho Code § 41-1015.

6. That subject to the approval of the Director of the Idaho Department of Insurance, the parties agree as follows:

- a. That Shey D. Pyne shall be granted a temporary license for a period of two (2) years;
- b. That Shey D. Pyne will comply at all times with the Insurance Code of the State of Idaho, namely title 41, Idaho Code;
- c. That Joseba Ebana, Idaho resident producer carrying license no. 87194 and branch sales manager of the Boise Idaho Banker's Life & Casualty Office shall be the suitable sponsor of Shey D. Pyne, and Joseba Ebana shall assume the responsibility for all actions of the temporary licensee, Shey D. Pyne.
- d. Unless other good cause exists that may arise hereafter, and upon successful completion as a temporary licensee for two years after entry of the Final Order herein, Shey D. Pyne shall be granted a resident producer license in accordance with procedures set forth in title 41, Idaho Code.
- e. And, that Joseba Ebana shall accept his responsibilities as suitable sponsor in writing.

**STIPULATION - 2** 

- f. That the statement of Joseba Ebana accepting the responsibility as a suitable sponsor of Shey D. Pyne is attached hereto as Exhibit "A" and incorporated herein as if set forth in full.
- g. That if at any time Joseba Ebana resigns his position as a suitable sponsor; it will be Shey D. Pyne's responsibility to obtain a new suitable sponsor within thirty (30) days of Joseba Ebana's notice of his intent to resign as a suitable sponsor.
- h. That failure to obtain a suitable sponsor as submitted to and approved by the Director of the Idaho Department of Insurance within the thirty (30) days will result in an order revoking the temporary license without prior hearing in accordance with Idaho Code § 41-1015(2).

7. That the parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein, and that they have entered into this Stipulation knowingly, voluntarily, and with full knowledge of any rights they may be waiving thereby. Additionally, the parties hereby waive the right to seek reconsideration and judicial review of the Final Order to be entered herein.

8. That the parties hereto waive their right to notice and hearing at which they may be represented by counsel, present evidence, and examine witnesses. The parties hereto also waive their right to submit this matter for review by a court of competent jurisdiction.

9. That the parties hereto have reviewed the proposed Final Order and agree as to its form and that said Final Order may be submitted to the Director of the Idaho Department of Insurance for his review and signature.

10. IT IS SO AGREED.
