ORDER GRANTING WITHDRAWAL FROM MEDICARE SUPPLEMENT MARKET

WHEREAS, UNITED TEACHER ASSOCIATES INSURANCE COMPANY

("UNITED TEACHER") notified the Idaho Department of Insurance ("Department") by electronic letter submitted January 28, 2011, that UNITED TEACHER intends to discontinue marketing Medicare Supplement policies, Plans A, B, C, D, F, G, and N, in Idaho effective May 31, 2010, which date reflects the discontinuance of its last actively marketed products; and

WHEREAS, UNITED TEACHER has represented to the Department that it will continue to service all of its existing in-force Medicare Supplement contracts in Idaho, which, as of the date of UNITED TEACHER's letter, was represented to be twenty (20); NOW, THEREFORE, IT IS HEREBY ORDERED that, pursuant to IDAPA

18.01.54.030.04.a, UNITED TEACHER is permitted to withdraw from the Medicare Supplement market in Idaho effective May 31, 2010, notwithstanding that thirty (30) days' advance notice was not given, because UNITED TEACHER failed to submit any Medicare Supplement policies for effective dates on and after June 1, 2010, as set forth in IDAPA 18.01.54.022, and the company represents that May 31, 2010, was the date it discontinued marketing its last Medicare Supplement products.

IT IS HEREBY FURTHER ORDERED that UNITED TEACHER shall not file a new policy form or certificate form of the same type for the same standard Medicare Supplement benefit plan as the discontinued forms or offer such products in Idaho prior to January 28, 2016, pursuant to IDAPA 18.01.54.030.04.b.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. *See* Section 67-5246(4), Idaho Code.

Pursuant to Sections 67-5270 and 67-5272, Idaho Code, any party aggrieved by this final order or orders previously issued in this case may appeal this final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- The party seeking review of the order resides, or operates its principal place of business in Idaho, or
- iv. The real property or personal property that was the subject of the agency action is located.

An appeal must be filed within twenty-eight (28) days of (a) the service date of this final order, (b) an order denying petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. *See* Section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.
