STIPULATION

The parties hereto, namely the Idaho Department of Insurance and the Applicant, Doug Adams, do hereby stipulate and agree as follows:

- 1. That the Director of the Idaho Department of Insurance has jurisdiction concerning the matters at issue herein in accordance with title 41, Idaho Code.
- 2. That DOUG ADAMS (hereinafter "Adams") made application for a resident producer's license with the Idaho Department of Insurance on or about July 26, 2011.
- 3. Upon review, it was the Department's initial position to deny the ADAMS' application for a resident producer's license.
 - 4. In furtherance of his application, Mr. Adams has provided additional evidence

and information with regard to his application for a resident producer's license.

- 5. That in his application for a resident license, Adams notified the Department that he entered a plea of guilty on a felony case before the District Court, Ada County, Idaho on December 9, 2009 in the Ada County Case No. CRFE-2009-0007492.
- 6. That the District Judge in that matter entered a withheld judgment in said matter and placed the Applicant on supervised probation for a period of six (6) years.
- 7. In consideration of all the information provided and the application in question, the staff of the Department is willing to grant to Adams a temporary license in accordance with title 41, Idaho Code; subject to the provisions of this stipulation and approval by the Director.
- 8. That Adams agrees and understands if at any time during the period of this temporary license, the Director finds that the interests of the insureds or the public are endangered, the Director may revoke the temporary license without prior notice to Adams.
- 9. That Adams agrees and understands that in the event the Director enters an order revoking the temporary license of Adams, he may petition for a hearing. If a hearing is requested, it is Adams' burden shall show cause why the temporary license should be reinstated.
- 10. That subject to the approval of the Director of the Idaho Department of Insurance, the parties agree as follows:
 - a. That Adams shall be granted a temporary license during the pendency of his probation, whether in a supervised or unsupervised status;
 - That such temporary license shall be renewed as required by law from time to time during the pendency of Adams' probation;
 - c. That upon termination of Adams' probation, it is the responsibility of Adams to notify the Department the date of termination of his

- probation and to provide any supporting documentation;
- d. That Adams will comply at all times with the Insurance Code of the State of Idaho, namely title 41, Idaho Code;
- e. That Adams will report any changes to his employment status, changes
 to his business and/or residential addresses, and any changes to his
 contact phone numbers and email address;
- f. That Adams shall make no application for licensing with any other state or jurisdictions relating to insurance without first contacting, and obtaining the written approval of, the Department.
- g. Unless other cause exists that may arise hereafter, upon successful completion of the Applicant's probationary period, the Department shall grant a resident producer license in accordance with procedures and standards set forth in title 41, Idaho Code.
- 11. That the parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein, and that they have entered into this Stipulation knowingly, voluntarily, and with full knowledge of any rights they may be waiving thereby. Additionally, the parties hereby waive the right to seek reconsideration and judicial review of the Final Order to be entered herein.
- 12. That the parties hereto waive their right to notice and hearing at which they may be represented by counsel, present evidence, and examine witnesses. The parties hereto also waive their right to submit this matter for review by a court of competent jurisdiction.
- 13. That Adams is fully apprised before executing this document of his right to counsel and to consult with an attorney with regard to this stipulation and proposed Final Order

and his rights and obligations hereunder.

14. That the parties hereto have reviewed the proposed Final Order and agree as to its form and that said Final Order may be submitted to the Director of the Idaho Department of Insurance for his review and signature.

15. IT IS SO AGREED.
