STIPULATION CONCERNING VERIFIED COMPLAINT

The parties herein, namely the Idaho Department of Insurance (the "Department") and its counsel of record, Richard B. Burleigh, Deputy Attorney General, and Harlan Delano Melton ("RESPONDENT"), non-resident Producer under title 41 of the Idaho Code, holding License No. 66397, and his counsel of record, Charles V. Carroll, Esq., attorney-at-law, do hereby agree and stipulate as follows:

 That as duly authorized as a non-resident Producer in Idaho, RESPONDENT falls within the jurisdiction of the Director of the Idaho Department of Insurance ("Director") and title
41 of the Idaho Code.

2. That on April 27, 2011, the Idaho Department of Insurance did file and serve a

Verified Complaint and Right to Hearing (hereinafter "Verified Complaint") on the RESPONDENT.

3. That said Verified Complaint alleged various violations of title 41, Idaho Code against RESPONDENT arising out of cross border sales of state of Idaho annuity policies issued by Allianz Life Insurance Company to state of Washington residents.

4. That RESPONDENT timely filed a Request for Hearing and Objection and Response to Verified Complaint on May 17, 2011, generally denying the allegation set forth in the Verified Complaint.

5. That RESPONDENT has allowed his non-resident producer license to lapse since the Department filed the Verified Complaint.

5. That the parties hereto believe that this matter may be brought to a close by a negotiated and stipulated settlement.

6. That, based on the foregoing, the parties agree and stipulate as follows:

a. That all of the Department's allegations set forth in the Verified Complaint concerning the following individuals are hereby withdrawn and dismissed by the Department with prejudice:

b. That RESPONDENT admits each of the allegations as set forth in the

Verified Complaint with regard to Barbara B. Frislie, Wayne L. Kjack, and Virginia L. Toland, specifically, that with regard to the insurance policies submitted on behalf of each individual as more particularly alleged in the Verified Complaint that RESPONDENT violated Idaho Code § 41-113(2), § 41-293(1)(c), § 41-293(1)(e), § 41-1016(1)(e) and 41-1016(1)(h) all as more particularly alleged in the Verified Complaint.

c. That notwithstanding the Director authority, pursuant to Idaho Code § 41-117, to impose an administrative penalty not to exceed \$1,000 per violation of the Idaho Insurance Code the Department hereby waives any and all claim for the violations of the Idaho Insurance Code by RESPONDENT as more particularly set forth above.

d. That RESPONDENT agrees that he shall not seek a renewed or new producer license, either residential or non-residential, from the Department and that RESPONDENT shall not engage in the business of insurance in the state of Idaho.

e. That an appropriate final order may be entered herein by the Director.

7. That the parties waive their right to notice and hearing at which they may be represented by counsel, present evidence and examine witnesses.

8. That the parties hereby waive the right to seek reconsideration and judicial review of the Final Order to be entered herein.

10. That the parties hereto have reviewed the proposed Final Order, attached hereto as <u>Exhibit A</u> and incorporated herein by this reference, and agree as to its form and that said Final Order may be submitted to the Director for review and signature.

9. That the parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein, and that they have entered into this Stipulation knowingly, voluntarily and with full knowledge of any rights they may be waiving thereby.



The parties herein, namely the Idaho Department of Insurance (the "Department") and its counsel of record, Richard B. Burleigh, Deputy Attorney General, and Harlan Delano Melton, non-resident Producer under title 41 of the Idaho Code, holding License No. 66397, and his counsel of record, Charles V. Carroll, Esq., attorney-at-law, having entered into a STIPULATION CONCERNING VERIFIED COMPLAINT on file herein, and the Director having reviewed the same, does hereby enter this Final Order as follows:

1. That Harlan Delano Melton, as a duly authorized as an Idaho non-resident Producer holding license No. 66397 during all times relevant under the Verified Complain, falls within the jurisdiction of the Director of the Idaho Department of Insurance and title 41 of the Idaho Code.

2. That Harlan Delano Melton stipulated to the violation of Idaho Code § 41-113(2), § 41-293(1)(c), § 41-293(1)(e), § 41-1016(1)(e) and 41-1016(1)(h) as a result of his actions arising out of cross border sales of state of Idaho annuity policies issued by Allianz Life Insurance Company to state of Washington residents, specifically, Barbara B. Frislie, Wayne L. Kjack, and Virginia L. Toland.

3. That Harlan Delano Melton allowed his non-resident producer license to lapse.

4. That the Department and Harlan Delano Melton agreed to resolve this matter by stipulation, a copy of which has been filed with the Director and which has been reviewed and approved.

Based on the foregoing and in consideration of the premises,

IT IS HEREBY ORDERED that the STIPULATION CONCERNING VERIFIED COMPLAINT on file herein is approved and adopted as an Order of the Director, and is incorporated herein as if set forth in full and made a part hereof; and,

IT IS FURTHER ORDERED that the Department's Verified Complaint to the extent it concern allegations regarding Lorraine M. Zehm, Larry Zehm, Susan Gilbert, Juanita R. Winger, Louise M. Carney, Margaret M. Finn, is hereby dismissed with prejudice; and,

IT IS FURTHER ORDERED that Harlan Delano Melton shall not seek to renew his non-resident producer license no. 66397, or obtain a new Idaho resident or non-resident producer license or practice the business of insurance in Idaho.

IT IS FURTHER ORDERED that no penalty shall be assessed against Harlan Delano Melton for the stipulated violations of the Idaho Code as set forth herein.




