## ORDER GRANTING REQUEST FOR BLOCK NONRENEWAL OF PERSONAL UMBRELLA POLICIES

The Director of the Idaho Department of Insurance ("Department"), having read and being fully apprised of the request of ALLSTATE INSURANCE COMPANY ("Petitioner") for permission to block nonrenew all of its personal umbrella policies in Idaho, which change will affect six hundred eighty-five (685) policies; and Petitioner having provided notice to the Director of the Department by letter dated June 29, 2011, as supplemented by that certain letter from Allstate to the Department dated August 22, 2011 and that certain letter from Allstate to the

Department of Insurance State of Idaho Department dated September 7, 2011, and having informed the Director that the affected policyholders shall be notified that Allstate Indemnity Company, an affiliate of Petitioner, will make every effort to retain the affected policyholders as more particularly outlined in the August 22, 2011 letter; and, in light of Idaho Code § 41-1841, good cause appearing therefor;

IT IS HEREBY ORDERED that this ratifies and confirms that the Petitioner is allowed, pursuant to Idaho Code § 41-1841, to effectuate a block nonrenewal of its personal umbrella policies in Idaho, which change will affect six hundred eighty-five (685) policies, beginning no sooner than One Hundred Twenty (120) days from its June 29, 2011, request, which is October 27, 2011. The Petitioner is to provide reasonable notice to policyholders affected by the nonrenewals allowed by this order in accordance with the policies. This order is a final order and is effective immediately.

#### NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. *See* section 67-5246(4), Idaho Code.

Pursuant to sections 67-5270 and 67-5272, Idaho Code, any party aggrieved by this final order or orders previously issued in this case may appeal this final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- The party seeking review of the order resides, or operates its principal place of business in Idaho, or
- iv. The real property or personal property that was the subject of the agency action is

located.

An appeal must be filed within twenty-eight (28) days of (a) the service date of this final order, (b) an order denying petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. *See* section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.
