ORDER PERMITTING DEVIATION FROM 2013 WORKERS' **COMPENSATION RATES**

WHEREAS, SENTRY CASUALTY COMPANY (Applicant) is a member of the National Council on Compensation Insurance, Inc. (NCCI); and

WHEREAS, the Applicant has applied for permission to deviate from certain Idaho workers' compensation rates filed by the NCCI for 2013, by applying a rate of \$0.00 (no charge) for Catastrophe (other than Certified Acts of Terrorism) coverage associated with its Idaho workers' compensation coverage, which rate represents a negative one hundred percent (-100%) deviation; and by applying a rate of \$0.01 for Terrorism coverage associated with its Idaho workers' compensation coverage, which rate represents a negative fifty percent (-50%) deviation; and

ORDER PERMITTING DEVIATION FROM 2013 WORKERS' COMPENSATION RATES - 1

WHEREAS, both the Applicant and the NCCI have indicated in writing that they do not request a hearing on the application; and

WHEREAS, the Director of the Department of Insurance, having reviewed and being fully apprised of the Applicant's request to deviate from the Idaho workers' compensation premium rates filed by the NCCI for 2013, has determined that the requested rate deviation is justified;

NOW, THEREFORE, IT IS HEREBY ORDERED that, pursuant to Idaho Code § 41-1614, the Applicant's request to apply a rate of \$0.00 (no charge) for Catastrophe (other than Certified Acts of Terrorism) coverage and a rate of \$0.01 for Terrorism coverage associated with the Applicant's Idaho workers' compensation coverage is GRANTED. This deviation from the Idaho workers' compensation premium rates filed by the NCCI for 2013 shall take effect on January 1, 2013, and shall remain in effect for one year from that date unless terminated sooner with the approval of the Director.
