STIPULATION CONCERNING VERIFIED COMPLAINT AND FINAL ORDER

The parties herein, namely the Idaho Department of Insurance (the "Department") and its counsel of record, Richard B. Burleigh, Deputy Attorney General, and GARY L. GOSSETT ("RESPONDENT"), non-resident Producer under title 41 of the Idaho Code, holding License No. 146975, do hereby agree and stipulate as follows:

- 1. That, as duly authorized as a non-resident Producer in Idaho, RESPONDENT falls within the jurisdiction of the Director of the Idaho Department of Insurance ("Director") and title 41 of the Idaho Code.
- That, on October 17, 2012, the Idaho Department of Insurance did file and serve a
 Verified Complaint and Right to Hearing (hereinafter "Verified Complaint") concerning the

actions of RESPONDENT.

- 3. That said Verified Complaint alleged various violations of title 41, Idaho Code, against RESPONDENT arising out of RESPONDENT's FINRA action, Docket No. 2009020793901 (the "FINRA Action"), the resolution date of which was April 23, 2012, including failure to report said FINRA Action in his Renewal Application for his non-resident producer license and failure to report the FINRA Action in response to inquiries from the Department.
- 4. That, on October 23, 2012, RESPONDENT timely filed a Request for Hearing in response to the Verified Complaint wherein RESPONDENT conceded the violations alleged in the Verified Complaint and requested a negotiated resolution to the Department's Verified Complaint.
- 5. That the parties hereto believe that this matter may be brought to a close by a negotiated and stipulated settlement.
 - 6. That, based on the foregoing, the parties agree and stipulate as follows:
- a. RESPONDENT admits each of the allegations as set forth in the Verified Complaint.
- RESPONDENT's Non-Resident Producer License No. 146975 shall be discontinued and revoked.
- c. A penalty in the amount of One Thousand Dollars (\$1,000.00) shall be imposed upon RESPONDENT, provided that such penalty shall be suspended but due and payable in full prior to submission by RESPONDENT of any application for a resident or non-resident producer license under title 41, Idaho Code.
- 7. That the parties waive their right to notice and hearing at which they may be represented by counsel, present evidence and examine witnesses.

- 8. That the parties hereby waive the right to seek reconsideration and judicial review of the Final Order to be entered herein.
- 9. That the parties hereto have reviewed the proposed Final Order, set forth below and incorporated herein by this reference, and agree as to its form and that said Final Order may be submitted to the Director for his review and signature.
- 10. That the parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein, and that they have entered into this Stipulation knowingly, voluntarily and with full knowledge of any rights they may be waiving thereby.
