**CONSENT ORDER** 

The parties herein, namely the Idaho Department of Insurance (the "Department"), by and through its counsel of record, Richard B. Burleigh, Deputy Attorney General, and HEATHER RAE HENRY ("HENRY"), resident producer under title 41 of the Idaho Code, holding Resident Producer License No. 386328, do hereby agree and stipulate as follows:

#### **FINDINGS OF FACT**

- 1. HENRY is and has been a licensed insurance producer in the state of Idaho, holding license No. 386328 since its original issuance date of August 24, 2011, and is therefore subject to the provisions of title 41, Idaho Code, and to the rules of the Idaho Department of Insurance promulgated thereunder, for acts occurring during that time period.
  - 2. At the time HENRY became a licensed producer in Idaho she was also a producer

in Washington state.

- On December 12, 2011, the State of Washington, Office of Insurance
   Commissioner, issued an Order Revoking License whereby HENRY's Washington producer
   license was revoked.
- 4. HENRY never reported the revocation of her Washington producer license to the Department as required by Idaho Code § 41-1021(1).
- 5. HENRY's address on file with the Department is 2714 S. San Marco Place, Nampa, ID 83686-1248. However, HENRY does not reside or have a place of business at this location.
- 6. Based on the Department's investigation, HENRY's address is 440 W. Wycliff Drive, Nampa, ID 83686.
  - 7. HENRY failed to notify the Department of this address change.

#### CONCLUSIONS OF LAW

- 8. Idaho Code § 41-1016(1)(b) provides that the director of the Department may impose an administrative penalty not to exceed one thousand dollars (\$1,000) and may revoke any license issued under chapter 10, title 41, Idaho Code, for Violating any provision of title 41, Idaho Code.
- 9. By failing to report the Washington administrative action whereby her license was revoked, HENRY violated Idaho Code § 41-1021(1).
- 10. By failing to report her address change within thirty (30) days of the change, HENRY violated Idaho Code § 41-1008(6).
- 11. The director of the Department is authorized under Idaho Code §§ 41-1016(1)(b) to impose a penalty of not more than \$1,000 per violation of the Idaho Insurance Code.

#### **SANCTIONS**

- 12. Based on the foregoing, HENRY and the Department agree that an administrative penalty in the amount of Five Hundred Dollars (\$500.00) shall be imposed upon HENRY, which shall be due and payable as follows:
  - a. Within ten (10) days following the entry of this Consent Order HENRY shall pay one hundred dollars (\$100.00) to the Department; and
  - b. Thereafter, Henry shall pay on the first day of each month commencing with June 1, 2013 and continuing through September 1, 2013, one hundred dollars (\$100.00) to the Department, for a total of four hundred dollars (\$400.00).
- 13. The parties waive their right to notice and hearing at which they may be represented by counsel, present evidence and examine witnesses.
- 14. The parties hereby waive the right to seek reconsideration and judicial review of the Consent Order entered herein.
- 15. The parties agree that the terms of this Consent Order are appropriate and proper under the circumstances referenced herein and that they have entered into this Consent Order knowingly, voluntarily and with full knowledge of any rights they may be waiving thereby.
