SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INSURANCE PRODUCER LICENSE

The Director of the Idaho Department of Insurance (“Director”) has been apprised of the voluntary surrender of MAURICE O. DYDELL’s Missouri resident insurance producer license. Accordingly, pursuant to Idaho Code § 41-1016(2), the Director enters this Summary Order revoking DYDELL’s Idaho Nonresident Producer License No. 649643.

FINDINGS OF FACT

1. According to records maintained by the National Association of Insurance Commissioners and by the Missouri Department of Commerce and Insurance, DYDELL was licensed as a resident insurance producer in his home state of Missouri until his license was voluntarily surrendered on March 7, 2021. The surrender was acknowledged by the Director of the Missouri Department of Commerce and Insurance by Voluntary License Surrender Order dated March 26, 2021.

2. The Director has not received notification that DYDELL has been relicensed as a resident in any other state.

3. Since January 17, 2018, DYDELL has been continuously licensed as an Idaho nonresident insurance producer under license number 649643.

CONCLUSIONS OF LAW

4. Idaho Code § 41-1016(2)(b)(i) provides that the Director shall, without hearing, suspend for not more than 12 months, or shall revoke or refuse to continue any nonresident insurance producer license issued under title 41, chapter 10, Idaho Code, where the nonresident no longer has a license in the licensee's home state because the home state license was "[v]oluntarily surrendered for any reason except relicensing as a resident in another state."

5. The Director finds these circumstances justify the revocation of DYDELL's Idaho nonresident insurance producer license under Idaho Code § 41-1016(2)(b)(i).

ORDER

NOW, THEREFORE, IT IS ORDERED that Idaho Nonresident Insurance Producer License No. 649643 issued to DYDELL is REVOKED, effective immediately.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this

final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.


