**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order in which the State Corporation Commission of the Commonwealth of Virginia (“Commission”) revoked Patricia Johnson Goins’ (“Goins”) license to transact the business of insurance in Virginia as an insurance agent. For the reasons discussed below, the Director enters this Summary Order Revoking Goins’ Idaho Nonresident Producer License, No. 7152200.

FINDINGS OF FACT

1. On March 8, 2019, Goins was licensed in her home state of Virginia as an individual insurance producer under Virginia License No. 564498.

2. On February 6, 2023, the Commission issued a final *Order Revoking License* against Goins. The Order found that Goins violated Virginia law by (1) making or causing or allowing to be made false or fraudulent statements or representations on or relative to a document relating to the business of insurance for the purpose of obtaining a benefit from an insurer; and (2) failing to pay funds to the insurer entitled to the payment. Goins’ license to transact the business of insurance in Virginia as an insurance agent was revoked and all appointments issued under said license became void.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

The administrative proceeding in which this order issued is reportable, and this order is a public record that may be disclosed to other states and reported to companies by which you are actively appointed. This information will be reported to the National Association of Insurance Commissioners (NAIC) and will appear in the Idaho Department of Insurance's online searchable database. Be aware that you must disclose this proceeding on any license application and must report it to any and all states in which you hold an insurance license.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
