**SUMMARY ORDER REVOKING  
IDAHO NONRESIDENT  
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order in which the Commissioner of the Insurance Department of the Commonwealth of Pennsylvania (“IDCP”) revoked Charles Lamar Harris’ (“Harris”) licenses to do the business of insurance in Pennsylvania.

For the reasons discussed below, the Director enters this Summary Order Revoking Harris’ Idaho Nonresident Producer License.

**FINDINGS OF FACT**

1. On December 26, 2006, the IDCP issued Harris an independent producer insurance agent license, number 9003100.

2. On March 28, 2023, Harris and the IDCP entered a Consent Order in which the IDCP found: (a) since May 2022, Harris used unlicensed assistants to sell, solicit, and/or negotiate insurance business, which requires licensure; (b) on September 7, 2022, the Pennsylvania Department of Revenue notified Harris that he had not complied with his personal tax obligations; (c) a tax lien was filed against Harris in the Court of Common Pleas, Allegheny County Pennsylvania; (d) on

November 8, 2022, Harris admitted he has co-mingled money since 2016, using accounts for both personal and business expenses including insurance premium deposits; and (e) Harris failed to report these actions to the IDCP within 30 days as required. Based on these findings, the Consent Order revoked Harris' independent insurance license and barred him from obtaining a new one for five years.

3. Harris has been licensed as an Idaho nonresident insurance producer since June 26, 2017.

### CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(a), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if the Director has received a final order of suspension, revocation, or refusal to continue from the insurance regulatory official or court of jurisdiction of the licensee's home state...

2. These circumstances justify revoking Harris' Idaho Nonresident Insurance Producer License under Idaho Code § 41-1016(2)(a).

### ORDER

NOW, THEREFORE, IT IS ORDERED that Harris' Idaho Nonresident Insurance Producer License is REVOKED, effective immediately.

The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See Idaho Code § 67-5246(4).*

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
