**SUMMARY ORDER REVOKING  
IDAHO NONRESIDENT  
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order in which the Commissioner of the Insurance Department of the Commonwealth of Pennsylvania “(IDCP)” revoked Shay Alanna Hunter’s (“Hunter”) licenses to do the business of insurance in Pennsylvania.

For the reasons discussed below, the Director enters this Summary Order Revoking Hunter’s Idaho Nonresident Producer License.

**FINDINGS OF FACT**

1. On October 12, 2021, the IDCP issued Hunter an independent producer insurance agent license, number 20080675.

2. On March 28, 2023, Hunter and the IDCP entered a Consent Order in which the IDCP found: (a) on October 8, 2022, the Huntingdon Borough Police charged Hunter with felony counts of theft by unlawful taking and receiving stolen property; (b) Hunter did not notify the IDCP of her criminal charges within 30 days, as required; (c) on or about November 18, 2022, the IDCP sent a letter to Hunter that warned her of the need to report criminal charges, and their final disposition, to

the IDCPC within 30 days; (d) on January 19, 2023, Hunter was convicted of one count of theft by unlawful taking, a misdemeanor, as a result of the above charges; and (e) Hunter failed to notify the IDCPC of the final disposition of the charges within 30 days as required. Based on these findings, the Consent Order revoked Hunter's license and barred her from obtaining a new one for five 5 years.

3. Hunter has been licensed as an Idaho nonresident insurance producer since October 15, 2021.

### CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(a), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if the Director has received a final order of suspension, revocation, or refusal to continue from the insurance regulatory official or court of jurisdiction of the licensee's home state...

2. These circumstances justify revoking Hunter's Idaho Nonresident Insurance Producer License under Idaho Code § 41-1016(2)(a).

### ORDER

NOW, THEREFORE, IT IS ORDERED that Hunter's Idaho Nonresident Insurance Producer License is REVOKED, effective immediately.

## **NOTIFICATION OF RIGHTS**

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
