**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order in which the Commissioner of the Maryland Insurance Administration (“Administration”), revoked Blaine J. Hamlett’s (“Hamlett”) resident insurance license in the state of Maryland.

For the reasons discussed below, the Director enters this Summary Order Revoking Hamlett’s Idaho Nonresident Producer License.

FINDINGS OF FACT

1. On February 16, 2022, the Administration issued Hamlett a resident insurance producer license number 135096.

2. On August 18, 2022, the Administration confirmed that two (2) felony Forgery-Unauthorized Act in Writing and two (2) misdemeanor Access Device Issued to Another Not Authorized, were pending against Hamlett in the Huntingdon County Pennsylvania criminal court. On September 22, 2022, Hamlett was sentenced on these charges and placed in an Accelerated Rehabilitative Disposition Program for three months.

3. On October 6, 2022, the Administration mailed a letter to Hamlett requesting additional information about the criminal charges and his failure to report the charges to the Administration. Hamlett failed to respond. On November 23, 2022, the Administration mailed and

emailed an "Order to Respond and Produce" to Hamlett, again requesting information about the criminal charges and his failure to report the same. Hamlett failed to respond.

4. On March 16, 2023, the Administration entered a final order finding that Hamlett violated Maryland law by (1) failing to report to the Administration his criminal prosecution; (2) failing to respond to the Administration's inquiry about the criminal charges; and (3) failed to respond to the Administration's Order to Respond and Produce. The Administration concluded that Hamlett's conduct demonstrates that he does not meet the standard of trustworthiness and competence required of an insurance producer and issued an Order revoking Hamlett's resident producer license and imposed a penalty of one thousand dollars (\$1,000).

5. Hamlett has been licensed as an Idaho nonresident insurance producer since May 5, 2022.

CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(a), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if the Director has received a final order of suspension, revocation, or refusal to continue from the insurance regulatory official or court of jurisdiction of the licensee's home state.

2. These circumstances justify revoking Hamlett's Idaho Nonresident Insurance Producer License under Idaho Code § 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS ORDERED that Hamlett's Idaho Nonresident Insurance Producer License is REVOKED, effective immediately.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See Idaho Code § 67-5246(4).*

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. *See Idaho Code § 67-5273.* Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. *Idaho Code § 67-5274.*
