SUMMARY ORDER REVOKING IDAHO NONRESIDENT INSURANCE PRODUCER LICENSE

The Director of the Idaho Department of Insurance ("Director") has received a final order in which the Director of the Florida Division of Insurance Agent and Agency Services, and Department of Financial Services ("DFS") revoked Alexandria Danielle Gelrod's ("Gelrod") licenses, appointments, and eligibility for licensure in the state of Florida. For the reasons discussed below, the Director enters this Summary Order Revoking Gelrod's Idaho Nonresident Producer License No. 18929272.

### FINDINGS OF FACT

- 1. On September 28, 2016, Gilrod was licensed in her home state of Florida as a life including variable annuity and health insurance agent under License No. W517751.
- 2. On May 8, 2023, DFS issued a final *Order of Revocation* revoking all licenses, appointments and eligibility for licensure issued to Gelrod that are within the purview of DFS. The Order found that Gelrod violated Florida law by (1) entering a plea of nolo contendere to Welfare Fraud, a felony, and being sentenced to five years of probation; and (2) failing to answer the Administrative Complaint DFS filed against her on February 8, 2023.

3. Gelrod has been licensed as an Idaho nonresident insurance producer since August 2, 2019.

#### **CONCLUSIONS OF LAW**

- 1. Per Idaho Code § 41-1016(2)(a), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if the Director has received a final order of suspension, revocation, or refusal to continue from the insurance regulatory official or court of jurisdiction of the licensee's home state.
- 2. These circumstances justify revoking Gelrod's Idaho Nonresident Insurance Producer License under Idaho Code § 41-1016(2)(a).

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that Gelrod's Idaho Nonresident Insurance Producer License is REVOKED, effective immediately.

The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
