**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order wherein the Iowa Insurance Commissioner (“Commissioner”) ordered Anna Kline’s, (“Kline”) license revoked in the state of Iowa. For the reasons discussed below, the Director enters this Summary Order Revoking Kline’s Idaho Nonresident Producer License No. 20235299.

FINDINGS OF FACT

1. On February 15, 2022, Kline was licensed in her home state of Iowa as a resident producer under License No. 20235299.
2. On August 3, 2023, the Commissioner entered a final *Default Order, Findings of Fact, Conclusions of Law and Order* revoking Kline’s Iowa resident producer license, effective August 19, 2023.
3. Kline has been licensed as an Idaho nonresident insurance producer since March 28, 2022.

CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(a), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if the Director has received a final order of suspension, revocation, or refusal to continue from the insurance regulatory official or court of jurisdiction of the licensee's home state.

2. These circumstances justify revoking Kline's Idaho Nonresident Producer License under Idaho Code § 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS ORDERED that Kline's Idaho Nonresident Producer License is REVOKED, effective immediately.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. *See* Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
