**SUMMARY ORDER REVOKING  
IDAHO NONRESIDENT  
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order in which the Insurance Commissioner of the state of California (“Commissioner”) revoked Ryan Anthony Garry’s (“Garry”) insurance producer license. For the reasons discussed below, the Director enters this Summary Order Revoking Garry’s Idaho Nonresident Producer License, NPN 19300655.

**FINDINGS OF FACT**

1. On September 25, 2019, Garry was licensed in his home state of California as an insurance producer under California License No.4002462.
2. On December 22, 2022, the California Department of Insurance served Garry with an Administrative Accusation Statement. The Accusation Statement noted that on or about March 29, 2022, Garry plead nolo contendere, and was convicted of, violating California law by false imprisonment and driving while under the combined influence of alcohol and drugs.
3. California’s Accusation Statement noted that Garry was required to notify the Commissioner of any changes in his “background information,”<sup>1</sup> including his mailing and email

<sup>1</sup> According to the Accusation, California Insurance Code Section 1729.2(c)(2) defined “Background information” as: “a misdemeanor or felony conviction; filing of felony criminal charges; an administrative action regarding a professional or

addresses, within thirty days. Garry failed to respond or file a "Notice of Defense" to the Accusation Statement and failed to provide updated contact information to the Commissioner.

4. On July 14, 2023, the Commissioner entered a final order that revoked Garry's license and licensing rights, effective thirty days from the date of the order.

5. Garry has been licensed as an Idaho nonresident insurance producer since October 3, 2019.

### CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(a), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if the Director has received a final order of suspension, revocation, or refusal to continue from the insurance regulatory official or court of jurisdiction of the licensee's home state.

2. These circumstances justify revoking Garry's Idaho Nonresident Insurance Producer License under Idaho Code § 41-1016(2)(a).

### ORDER

NOW, THEREFORE, IT IS ORDERED that Garry's Idaho Nonresident Insurance Producer License is REVOKED, effective immediately.

## **NOTIFICATION OF RIGHTS**

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
