**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order in which the Insurance Commissioner of the state of California (“Commissioner”) revoked Jeffrey Foster Goble’s (“Goble”) insurance producer license. For the reasons discussed below, the Director enters this Summary Order Revoking Gobel’s Idaho Nonresident Producer License, NPN 16007363.

FINDINGS OF FACT

1. On November 4, 2010, Goble was licensed in his home state of California as an insurance producer under California License No.0H21625.
2. On February 8, 2023, Gobel’s license was suspended in the state of Indiana by the Commissioner of Insurance due to Gobel’s failure to provide a list of his appointments. Goble’s license was subsequently revoked by the Indiana Commissioner of Insurance on June 30, 2023.
3. Gobel failed to report the administrative actions taken against him in Indiana to the Commissioner as a change in the background information pursuant to California law.
4. On March 28, 2023, and May 17, 2023, the Commissioner sent correspondence to Goble relative to an investigation or to an application for, or the retention or renewal of a license.

Goble failed to respond within 21 days as required by California law.

5. On August 31, 2023, the Commissioner entered a final order that revoked Goble's license and licensing rights, effective thirty days from the date of the order.

6. Goble has been licensed as an Idaho nonresident insurance producer since August 16, 2018.

CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(a), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if the Director has received a final order of suspension, revocation, or refusal to continue from the insurance regulatory official or court of jurisdiction of the licensee's home state.

2. These circumstances justify revoking Goble's Idaho Nonresident Insurance Producer License under Idaho Code § 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS ORDERED that Goble's Idaho Nonresident Insurance Producer License is REVOKED, effective immediately.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See Idaho Code § 67-5246(4).*

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
