**SUMMARY ORDER
REVOKING IDAHO
NONRESIDENT INSURANCE
PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received notice of the entry of an order by the Director of the Florida Division of Insurance Agent and Agency Services revoking Florida resident producer license No. W597143 issued to Dominique Symone Spencer (“Spencer”). Having reviewed the Florida order issued on November 13, 2023, and pursuant to Idaho Code § 41-1016(2)(a), the Director enters this Summary Order revoking Spencer’s Idaho Nonresident Insurance Producer License No. 19294055.

FINDINGS OF FACT

1. Spencer, at all times relevant hereto, held a Florida resident insurance producer license.
2. On or about March 21, 2023, Spencer entered a plea of no contest to a third-degree felony in the Circuit Court in and for Escambia County, Florida. Based upon this case, the Florida Division of Insurance Agent and Agency Services filed an administrative action on June 27, 2023, seeking revocation of Spencer’s license. Spencer did not respond to this complaint. The Florida Division of Insurance Agent and Agency Services issued an order revoking Spencer’s license on November 13, 2023.

3. Spencer has held an Idaho nonresident insurance producer license, numbered 19294055, since September 15, 2022.

CONCLUSIONS OF LAW

1. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, suspend for not more than 12 months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state.
2. The Director finds that the above circumstances justify the revocation of Spencer's Idaho nonresident insurance producer license, pursuant to Idaho Code § 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS ORDERED that Idaho Nonresident Insurance Producer License No. 19294055 issued to Spencer is REVOKED effective immediately.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or


iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
