SUMMARY ORDER REVOKING IDAHO NONRESIDENT INSURANCE

Idaho Nonresident Producer License,

PRODUCER LICENSE

The Director of the Idaho Department of Insurance ("Director") has received notice of the entry of an order by the Commissioner of Insurance of the South Carolina Department of Insurance indefinitely revoking national producer license no. 20138284 issued to Shagaria Morris ("Morris"). Having reviewed the South Carolina order issued on January 18, 2024, and pursuant to Idaho Code §§ 41-1016(1)(i) and 41-1016(2)(a), the Director enters this Summary Order revoking Morris's Idaho Nonresident Insurance Producer License No. 20138284.

FINDINGS OF FACT

- Morris, at all times relevant hereto, held a South Carolina resident insurance 1. producer license.
- 2. On January 18, 2024, the South Carolina Commissioner of Insurance issued an Affidavit of Default and a Default Order Revoking All Licensing revoking Morris's South Carolina resident insurance producer license effective January 17, 2024.
- 3. Morris has been licensed as an Idaho nonresident insurance producer under license number 20138284 since its issuance on January 12, 2022.

CONCLUSIONS OF LAW

- 1. Idaho Code § 41-1016(1)(i) provides that the director may impose an administrative penalty or may suspend, revoke or refuse to issue any license issued under title 41, chapter 10, Idaho Code, for having a license revoked in any other state.
- 2. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, suspend for not more than 12 months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state.
- 3. The Director concludes that the above circumstances justify the revocation of Morris's Idaho nonresident insurance producer license, pursuant to Idaho Code §§ 41-1016(1)(i) and 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS ORDERED that Idaho Nonresident Insurance Producer License No. 20138284 issued to Morris is REVOKED effective immediately.

operation of law. See Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order

or orders previously issued in this case may file a petition for judicial review in the district court

of the county in which:

i. A hearing was held;

ii. The final agency action was taken;

iii. The party seeking review of the order resides, or operates its principal place of

business in Idaho; or

iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
