**ORDER CONTINUING
SUSPENSION OF CERTIFICATE OF
AUTHORITY**

NORTH CAROLINA MUTUAL LIFE INSURANCE COMPANY (the “Company”) is a North Carolina-domiciled insurer licensed to transact life and disability insurance, excluding managed care, in the state of Idaho under Certificate of Authority No. 1205. By orders entered March 11, 2019, February 3, 2020, December 23, 2020, November 2, 2021, September 13, 2022, November 15, 2023, and November 26, 2024, the Director of the Idaho Department of Insurance (“Director”) suspended the Company’s Idaho Certificate of Authority. With this Order, the Director continues the suspension as discussed below.

On December 3, 2018, the Company was placed under an Order of Rehabilitation by the Superior Court of Wake County, North Carolina, in Case No. 18-CVS-14480, based on the petition of the Director of the North Carolina Commissioner of Insurance and the consent of the Company’s board of directors.

On October 11, 2022, the Court declared that the Company was insolvent and was placed under an Order of Liquidation, Injunctive Relief and Approval of Service Agreement and Early

Access Agreement.

Idaho Code § 41-327(3) provides that the Director may, without advance notice or hearing, “immediately suspend the certificate of authority of any insurer as to which proceedings for receivership, conservatorship, rehabilitation, or other delinquency proceedings have been commenced in any state by the public insurance supervisory official of such state.”

The Director, having reviewed the foregoing and the requirements of Idaho Code § 41-327(3), hereby finds that NORTH CAROLINA MUTUAL LIFE INSURANCE COMPANY is subject to delinquency proceedings within the meaning of Idaho Code § 41-327(3). Based on these findings, and good cause appearing:

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to Idaho Code § 41-327(3) that Certificate of Authority No. 1205 issued to NORTH CAROLINA MUTUAL LIFE INSURANCE COMPANY is CONTINUED IN SUSPENDED, effective immediately, for a period of one (1) year from the date of this order. The Director may terminate the suspension sooner if the cause for said suspension is corrected and the Company is otherwise in compliance with title 41, Idaho Code.

IT IS FURTHER ORDERED that NORTH CAROLINA MUTUAL LIFE INSURANCE COMPANY will comply with Idaho Code § 41-329, including § 41-329(2), which states: “During the suspension period the insurer shall not solicit or write any new business in this state, but shall file its annual statement, pay fees, licenses, and taxes as required under this code, and may service its business already in force in this state, as if the certificate of authority had continued in force.”

IT IS FURTHER ORDERED, pursuant to Idaho Code § 41-330(1), that, within four (4) days after notice of this suspension is provided, NORTH CAROLINA MUTUAL LIFE INSURANCE COMPANY will notify, by any available means, every person authorized to write

business in the state of Idaho by said insurance company, to immediately cease to write any further business for the Company in Idaho.

IT IS FURTHER ORDERED that, within sixty (60) days of the date of this order, NORTH CAROLINA MUTUAL LIFE INSURANCE COMPANY will file with the Director a complete listing of its policies owned by or issued to residents of Idaho.

IT IS FURTHER ORDERED that such list will include the name and address of each policyholder and insured, policy type, face amount, and case surrender value of the policy, as applicable.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the motion for reconsideration within twenty-one (21) days of its receipt, or the motion will be considered denied by operation of law. See Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within twenty-eight (28) days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
