**ORDER OF REINSTATEMENT OF  
CERTIFICATE OF AUTHORITY**

Idaho Certificate of Authority No. 2989 issued to GATEWAY INSURANCE COMPANY (“Gateway”), an Illinois-domiciled insurer licensed to transact property and casualty insurance in the state of Idaho under said certificate of authority, was suspended by the Director of the Idaho Department of Insurance (“Director”) by orders entered September 16, 2024, and August 20, 2025. Such suspension was in accordance with Idaho Code § 41-327(3) based on the *Agreed Order of Rehabilitation* against Gateway entered by the Circuit Court of Cook County, Illinois in Case No. 2023-CH-09563 on June 13, 2024.

Gateway was removed from rehabilitation status on or about September 29, 2025.

The Director, having reviewed the foregoing and the requirements of Idaho Code § 41-327(3), hereby finds that grounds no longer exist for suspension of Gateway’s Idaho certificate of authority. Based on these findings, and good cause appearing:

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to Idaho Code § 41-329(1), that Idaho Certificate of Authority No. 2989 issued to GATEWAY INSURANCE COMPANY is REINSTATED, effective IMMEDIATELY.

## NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the motion for reconsideration within twenty-one (21) days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Any such motion for reconsideration shall be served on the Director of the Idaho Department of Insurance, addressed as follows:

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within twenty-eight (28) days of: (a) the service date of this final order, (b) the service of an order denying a motion for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a motion for reconsideration, whichever is later. *See* Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
