**SUMMARY ORDER
REVOKING IDAHO
NON-RESIDENT INSURANCE
PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received notice of the entry of an order by the New York State Department of Financial Services wherein APRIL WILLIAMS’ (“Williams”) resident producer license number 20142777 was voluntarily surrendered in the state of New York. For the reasons discussed below and pursuant to Idaho Code § 41-1016(2)(b)(i), the Director enters this Summary Order revoking Williams’ Idaho Non-Resident Producer License No. 20142777.

FINDINGS OF FACT

1. Williams, at all times relevant hereto, held a New York resident producer license.
2. On January 8, 2026, the New York State Department of Financial Services issued an order wherein Williams’ resident producer license was voluntarily surrendered in the state of New York effective January 8, 2026.

3. Williams has been licensed as an Idaho non-resident insurance producer under license number 20142777 since its issuance on February 19, 2024.

CONCLUSIONS OF LAW

4. Idaho Code § 41-1016(2)(b)(i) provides that the Director shall, without hearing, suspend for not more than 12 months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the non-resident no longer has a license in the licensee's home state because the home state license was voluntarily surrendered for any reason except relicensing as a resident in another state.

5. The Director concludes that the above circumstances justify the revocation of Williams' Idaho non-resident producer license, pursuant to Idaho Code § 41-1016(2)(b)(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Idaho Non-Resident Insurance Producer License No. 20142777 issued to APRIL WILLIAMS is REVOKED effective immediately.

NOTICE REGARDING REPORTABLE PROCEEDINGS

This is considered a reportable administrative proceeding. This information will be reported to the National Association of Insurance Commissioners (NAIC) and will appear in the online searchable database of the Idaho Department of Insurance. Be aware that this proceeding must be disclosed on any license application and must be reported to any and all states in which you hold an insurance license.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which: (1) a hearing was held; or (2) the final agency action was taken; or (3) the party seeking review of the order resides or operates its principal place of business in Idaho; or (4) the real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order; or (b) the service of an order denying the motion for reconsideration; or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. *See* Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. *See* Idaho Code § 67-5274.
