SUMMARY ORDER REVOKING IDAHO NONRESIDENT INSURANCE PRODUCER LICENSES

The Director of the Idaho Department of Insurance ("Director") has received notice of the entry of an order by the Washington Insurance Commissioner suspending the Washington resident insurance producer licenses of VICKI L. BOSER ("BOSER") and INSURANCETEK, INC. ("INSURANCETEK"), as further described below. Upon review of such order, and, pursuant to the authority granted by Idaho Code § 41-1016(2), the Director hereby makes the following findings and enters a Summary Order as follows:

### **FINDINGS OF FACT**

- 1. BOSER and INSURANCETEK, at all times relevant hereto, were licensed as resident insurance producers in the state of Washington. BOSER is currently, and at all times relevant hereto was, the owner of INSURANCETEK.
- 2. On or about January 27, 2017, the Washington Insurance Commissioner issued an Order Suspending Licenses Pending Revocation, as Order No. 17-0014 ("Suspension Order"), which suspended the resident insurance producer licenses of BOSER and INSURANCETEK effective February 1, 2017, pending conclusion of license revocation proceedings and finalization of an Order Revoking License served concurrently with the Suspension Order. Such Suspension Order was based on findings of violations of Washington law by BOSER and INSURANCETEK, including fraud, dishonest practices, lack of fitness or trustworthiness, forgery, conversion, failing to respond, willfully collecting excess premium, and failing to forward premium monies. The Suspension Order was further based on the Washington Insurance Commissioner's determination that such action is necessary to protect the public.
- 3. BOSER has been continuously licensed as an Idaho nonresident insurance producer, holding license number 108910, from the date of the initial issuance of such license on January 8, 2004, to the present date.
- 4. INSURANCETEK has been continuously licensed as an Idaho nonresident insurance producer, holding license number 108909, from the date of the initial issuance of such license on January 8, 2004, to the present date. Idaho Department of Insurance records reflect that BOSER is the designated responsible licensed producer for INSURANCETEK, pursuant to Idaho Code § 41-1007(2)(b).

## **CONCLUSIONS OF LAW**

5. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, suspend for not more than twelve (12) months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state.

6. Based on the foregoing, the Director finds that the circumstances set forth above justify the revocation of the Idaho nonresident insurance producer licenses of BOSER and INSURANCETEK, pursuant to Idaho Code § 41-1016(2)(a).

### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Idaho Nonresident Insurance Producer License No. 108910 issued to BOSER is hereby REVOKED effective immediately.

IT IS FURTHER ORDERED that Idaho Nonresident Insurance Producer License No. 108909 issued to INSURANCETEK is hereby REVOKED effective immediately.

IT IS FURTHER ORDERED, pursuant to Idaho Code § 41-1027(1), that BOSER and INSURANCETEK shall immediately return Idaho Nonresident Insurance Producer License Nos. 108910 and 108909, respectively, to the Idaho Department of Insurance at the following address: 700 West State Street, P.O. Box 83720, Boise, Idaho, 83720-0043.

## **NOTIFICATION REGARDING REPORTABLE PROCEEDINGS**

This is considered a reportable administrative proceeding. Be aware that this proceeding must be disclosed on any license application and must be reported to any and all states in which you hold an insurance license.

### **NOTIFICATION OF RIGHTS**

This is a final order of the Director. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order may appeal this order by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho, or
- iv. The real property or personal property that was the subject of the agency action is located.

An appeal must be filed within twenty-eight (28) days of (a) the service date of this final order, (b) an order denying petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. See Idaho Code

§ 67-5273. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.
