ORDER PERMITTING DEVIATION FROM 2018 WORKERS' COMPENSATION RATES

On or about November 14, 2017, the Idaho Department of Insurance (Department) received from AIG PROPERTY CASUALTY COMPANY (AIGPCC), a Pennsylvania-domiciled insurer licensed to transact workers' compensation insurance in the state of Idaho pursuant to Certificate of Authority No. 242, and a member of the National Council on Compensation Insurance, Inc. (NCCI), a request for permission to deviate from the workers' compensation rates filed by the NCCI for 2018 by a uniform percentage increase of seven and one-half percent (7.5%).

AIGPCC and the NCCI have each waived the right to a hearing on the deviation request.

The Department's Director (Director), having reviewed and being fully apprised of AIGPCC's request to deviate from the Idaho workers' compensation premium rates filed by the

NCCI for 2018, and the requirements of Idaho Code § 41-1614, has determined that the requested rate deviation is justified.

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to Idaho Code § 41-1614, that AIGPCC's request to deviate by a uniform percentage <u>increase</u> of seven and one-half percent (7.5%) from the workers' compensation rates filed by the NCCI for 2018, exclusive of terrorism and catastrophe rating values, is GRANTED. This deviation from the Idaho workers' compensation premium rates filed by the NCCI for 2018 shall take effect on January 1, 2018, and shall remain in effect for one year from that date unless terminated sooner with the approval of the Director.
