ORDER AUTHORIZING WITHDRAWAL FROM MEDICARE SUPPLEMENT MARKET

On or about November 20, 2017, the Idaho Department of Insurance ("Department") received from AMERICAN REPUBLIC INSURANCE COMPANY ("AMERICAN REPUBLIC") notice of its intent to withdraw from the Medicare Supplement market in Idaho, effective January 1, 2018, by discontinuing the availability of its Medicare Supplement plans.

AMERICAN REPUBLIC acknowledged that its withdrawal of Medicare Supplement policies from sale in Idaho will prohibit AMERICAN REPUBLIC from filing for approval in Idaho a new policy form or certificate form of the same type for the same standard Medicare Supplement benefit plans as the discontinued forms for a period of five (5) years from the date of AMERICAN REPUBLIC's notice to the Department, pursuant to the requirements of IDAPA

18.01.54.030.04.b. AMERICAN REPUBLIC represented that it will continue to service all of its

existing in-force Medicare Supplement policies covering Idaho insureds, which will continue to

provide guaranteed renewable coverage without a change in benefits so long as premiums are paid

when due.

AMERICAN REPUBLIC's notice of intent to withdraw from the Medicare Supplement

market in Idaho appears to comply with the notice requirements to the Department's Director

("Director") as set forth in IDAPA 18.01.54.030.04.a.

The Director, having reviewed the foregoing and the requirements of IDAPA

18.01.54.030.04, and good cause appearing therefor,

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to IDAPA 18.01.54.030.04.a,

that AMERICAN REPUBLIC is authorized to withdraw from the Medicare Supplement market

in Idaho, effective January 1, 2018.

IT IS HEREBY FURTHER ORDERED, pursuant to IDAPA 18.01.54.030.04.b, that

AMERICAN REPUBLIC shall not file with the Department a new policy form or certificate form

of the same type for the same standard Medicare Supplement benefit plans as the discontinued

forms prior to November 20, 2022.

NOTIFICATION OF RIGHTS

This Order constitutes a final order of the Director. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The Director will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See, Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order may appeal it by filing a petition for judicial review in the district court of the county in which: (1) the hearing was held; or (2) the final agency action was taken; or (3) the aggrieved party resides or operates its principal place of business in Idaho; or (4) the real property or personal property that was the subject of the agency decision is located. An appeal must be filed within twenty-eight (28) days of: (a) the service date of this final order; or (b) an order denying a petition for reconsideration; or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. *See*, Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal.
