STIPULATION AND ORDER FOR ISSUANCE OF PRODUCER LICENSE

STIPULATION

COME NOW the Idaho Department of Insurance ("Department") and ANDREW TALBOT-GOODING COLWELL ("COLWELL") and do hereby stipulate and agree as follows:

- The Director of the Department has jurisdiction over this matter pursuant to title
 Idaho Code.
- 2. On or about July 18, 2018, the Department received from COLWELL an application for an Idaho Resident Insurance Producer License ("Application").

- 3. COLWELL disclosed and provided documentation with his Application, and in subsequent communication with the Department, indicating that he was convicted in federal court on May 27, 2015, pursuant to 21 U.S.C. § 841(a)(1). COLWELL began a supervised released on June 15, 2017. On February 27, 2018, it was determined by the U.S. Probation and Pretrial Services Offices in the U.S. District of Idaho, that COLWELL was low-risk and should be placed on a caseload of offenders who are low-risk to reoffend, have done well on supervision, and are expected to continue to do well. It was also noted by the same office that COLWELL has not had any instances of non-compliance and has abided by all the conditions of his supervision which is set to expire on June 14, 2020.
- 4. COLWELL passed insurance examinations in the lines of property and casualty insurance on July 13, 2018, and July 17, 2018 respectively.
- 5. Upon review of COLWELL's Application and related documents provided to the Department, the Department is willing to issue a resident insurance producer license to COLWELL on a temporary recurring six-month basis, in accordance with section 41-1015, Idaho Code, subject to the following terms and conditions:
 - a. COLWELL agrees that, no later than six (6) months after entry of the Order herein, and continuing every six (6) months thereafter until such time as COLWELL is fully released from probation, COLWELL shall report and provide documentation to the Department demonstrating COLWELL's current probationary status, including any violations or other events or items related to his probation, his current address and contact information, and other information as deemed necessary by the licensing supervisor at the Idaho Department of Insurance.

- b. The parties agree that COLWELL's failure to report as herein required shall result in immediate revocation of COLWELL's resident insurance producer license without prior notice or hearing.
- c. The parties agree that the Director may at any time, by order, revoke the temporary licensed granted hereunder without the right to a prior hearing if the interests of insureds or the public are endangered.
- 6. The parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein, and that they have entered into this Stipulation knowingly, voluntarily and with full knowledge of any rights they may be waiving thereby.
- 7. Before executing this Stipulation, the parties have had the opportunity to review this Stipulation with their respective attorneys and to seek appropriate advice and counsel relating to this Stipulation and Order.
- 8. The parties waive their right to notice and hearing at which they may be represented by counsel, present evidence and examine witnesses. The parties further waive their right of reconsideration, appeal, and other rights as set forth in title 41 and title 67, chapter 52, Idaho Code, including the right to submit this matter for review by a court of competent jurisdiction.
- 9. This Stipulation is subject to approval by the Director or the Director's designee, and shall become effective and binding upon the Department and COLWELL upon such approval. Should the Director decline to approve this Stipulation, the Department and COLWELL shall retain all of their rights, claims and/or defenses, and any factual and/or legal admissions made by COLWELL herein shall be withdrawn.
- 10. This Stipulation embodies the entire agreement between the Department and COLWELL, and there are no agreements, understandings, representations or warranties that are not expressly set forth herein.

- 5. That ANDREW TALBOT-GOODING COLWELL's failure to report as ordered herein will result in the immediate revocation of ANDREW TALBOT-GOODING COLWELL's temporary Idaho Resident Insurance Producer License without prior notice or hearing.
