

ORDER PERMITTING DEVIATION FROM 2019 WORKERS' COMPENSATION RATES

On or about October 15, 2018, the Idaho Department of Insurance (Department) received from ILLINOIS INSURANCE COMPANY (ILLINOIS INSURANCE), an Iowa-domiciled insurer licensed to transact workers' compensation insurance in the state of Idaho pursuant to Certificate of Authority No. 2808, and a member of the National Council on Compensation Insurance, Inc. (NCCI), a request for permission to deviate from the workers' compensation rates filed by the NCCI for 2019 by a uniform percentage decrease of ten percent (10%).

ILLINOIS INSURANCE and the NCCI have each indicated in writing that they do not request a hearing on the deviation request.

The Department's Director (Director), having reviewed and being fully apprised of ILLINOIS INSURANCE's request to deviate from the Idaho workers' compensation premium ORDER PERMITTING DEVIATION FROM 2019 WORKERS' COMPENSATION RATES - 1

rates filed by the NCCI for 2019, and the requirements of Idaho Code § 41-1614, has determined that the requested rate deviation is justified.

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to Idaho Code § 41-1614, that ILLINOIS INSURANCE's request to deviate by a uniform percentage decrease of ten percent (10%) from the workers' compensation rates filed by the NCCI for 2019, exclusive of terrorism and catastrophe rating values, is GRANTED. This deviation from the Idaho workers' compensation premium rates filed by the NCCI for 2019 shall take effect on January 1, 2019, and shall remain in effect for one year from that date unless terminated sooner with the approval of the Director.
