Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order may appeal it by filing a petition for judicial review in the district court of the county in which: (1) the hearing was held; or (2) the final agency action was taken; or (3) the aggrieved party resides or operates its principal place of business in Idaho; or (4) the real property or personal property that was the subject of the agency decision is located. An appeal must be filed within twenty-eight (28) days of: (a) the service date of this final order, or (b) an order denying a petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review to the district court does not itself stay the effectiveness or enforcement of the order under appeal.

VERIFIED COMPLAINT AND NOTIFICATION OF RIGHTS

The Idaho Department of Insurance (hereinafter "Department"), by and through its attorney of record, John C. Keenan, Deputy Attorney General, does hereby complain and allege as follows:

- 1. The Director of the Department has jurisdiction in the state of Idaho over matters involving insurance regulation and licensing, in accordance with title 41, Idaho Code.
- 2. This administrative proceeding is brought under the provisions of the Idaho Insurance Code, Idaho Code § 41-101 et seq., including Idaho Code § 41-1016, which authorizes

the Department to initiate a contested case against an Idaho-licensed insurance producer including an individual or an agency, seeking revocation of the insurance producer's license, as well as the imposition of administrative penalties in accordance with section 41-1016, Idaho Code, if the Director of the Department finds that any one or more of the causes or violations set forth in subsections (1)(a) through -(o) of that section exists.

3. Pursuant to section 41-1026(3), Idaho Code, the Director shall not issue a license under title 41, Idaho Code, to any person whose license has been revoked until after the expiration of not less than one (1) year to a maximum of five (5) years and, upon a former licensee's application for re-licensure, the Director may require the former licensee "to show good cause why the prior revocation ... shall not be deemed a bar to the issuance of a new license."

RESPONDENT

4. JOSHUA MALLEN (hereinafter "Mallen") is a resident of the state of Florida and holds Idaho Nonresident Producer License No. 467115, which was originally issued on November 5, 2013.

FACTS

- 5. On October 16, 2018, the Department sent to Mallen a request for information pursuant to section 41-247, Idaho Code, via first class U.S. Mail to his then-current residential address and his email address both on record at the Idaho Department of Insurance.
- 6. On or about October 17, 2018, Mallen contacted the Department by telephone asking if the Department had received his response from his appointed insurer. The Department communicated to Mallen that his full response to the Department's detailed inquiry was required and that such response must be in writing.
 - 7. As of the undersigned date, Mallen has not responded to the original inquiry nor to

a subsequent follow-up inquiry directed to Mallen via email on November 15, 2018.

8. By failing to fully respond, Mallen has violated section 41-247, Idaho Code, which gives the Department cause to seek revocation of Mallen's license and imposition of a monetary penalty, pursuant to section 41-1016(1)(b), Idaho Code.

PRAYER FOR RELIEF

Based on the foregoing, the Department prays for relief as follows:

- 1. That the Director find that Mallen violated the law as alleged; and
- 2. That the Director enter an order REVOKING Mallen's Idaho Nonresident Producer License No. 467115 and providing that Mallen shall not be issued any license under title 41, Idaho Code, for a period of one (1) year; and
- 3. That the Director enter an order imposing an administrative penalty against Mallen in the amount of \$1,000 per violation, for a total of \$1,000.00.
