ORDER AUTHORIZING BLOCK NONRENEWAL AND WITHDRAWAL FROM LARGE GROUP HEALTH INSURANCE MARKET

On or about June 26, 2020, the Idaho Department of Insurance ("Department") received notification from NATIONAL HEALTH INSURANCE COMPANY ("NHIC") of its intent to withdraw from the large group health insurance market in Idaho by discontinuing the offering of new policies and by block nonrenewing its existing large group health insurance policies delivered or issued for delivery in Idaho, pursuant to Idaho Code § 41-2223(1)(h), beginning January 2, 2021.

NHIC represents to the Department that it will provide a minimum of one hundred eighty (180) days' written notice to affected plan sponsors of its intent to nonrenew the subject policies. NHIC further represents that, as of June 30, 2020, the proposed block nonrenewal will affect fifteen (15) large group policies with a total of two hundred sixty-four (264) members.

The Director, having reviewed the foregoing and finding that the proposed block

nonrenewal complies with the notice requirements of Idaho Code §§ 41-1841(1) and 41-

2223(1)(h), and good cause appearing therefor,

NOW THEREFORE, IT IS HEREBY ORDERED that NHIC is authorized, pursuant to

Idaho Code §§ 41-1841(1) and 41-2223(1)(h), to effectuate a block nonrenewal and discontinue

all of its large group health insurance policies in Idaho, beginning January 2, 2021.

IT IS FURTHER ORDERED that NHIC shall provide written notice of not less than one

hundred eighty (180) days to any Idaho employer affected by the nonrenewals authorized by this

order, in accordance with the notice provisions included in the company's applicable insurance

policies and with the requirements of Idaho Code § 41-2223(1)(h).

IT IS FURTHER ORDERED that NHIC is prohibited from offering and writing any new

business in the large group health insurance markets in Idaho prior to June 26, 2025, pursuant to

Idaho Code § 41-2223(2).

THIS ORDER is a final order of the Director and is EFFECTIVE IMMEDIATELY.

## **NOTIFICATION OF RIGHTS**

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the motion for reconsideration within twenty-one (21) days of its receipt, or the motion will be considered denied by operation of law. See Idaho Code § 67-5246(4).

Any such motion for reconsideration shall be served on the Director of the Idaho Department of Insurance, addressed as follows:

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within twenty-eight (28) days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
