**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”), has received notice of the entry of an order by the Wisconsin Insurance Commissioner revoking the Wisconsin resident insurance license issued to ANGELA TOLBERT (“TOLBERT”), as further described below. Upon review of such order, and pursuant to the authority granted by Idaho Code § 41-1016(2)(a), the Director does hereby make the following findings and enter a Summary Order as follows:

FINDINGS OF FACT

1. TOLBERT, at all times relevant hereto, held a Wisconsin resident insurance license.
2. On or about November 10, 2020, the Wisconsin Insurance Commissioner issued an order in File No. 20-C43798, revoking TOLBERT’s Wisconsin resident insurance license, based on certification by the Wisconsin Department of Revenue that TOLBERT is liable for delinquent Wisconsin taxes. Such revocation order became effective on or about December 11, 2020.
3. TOLBERT has been continuously licensed as an Idaho nonresident insurance producer, holding license number 753064 from the date of the initial issuance of such license on November 12, 2019, to the present date.

CONCLUSIONS OF LAW

4. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, suspend for not more than twelve (12) months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state. Based on the foregoing, the Director finds that the circumstances set forth above justify the revocation of TOLBERT's Idaho nonresident insurance producer license, pursuant to Idaho Code § 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Idaho Nonresident Insurance Producer License No. 753064 issued to TOLBERT is hereby REVOKED, effective immediately.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

NOTIFICATION OF RIGHTS

This a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the motion for reconsideration within twenty-one (21) days of its receipt, or the motion will be considered denied by operation of law. See Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within twenty-eight (28) days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
