ORDER DECLARING CLASSES OF INSURANCE COVERAGE OR RISK ELIGIBLE FOR EXPORT

On June 24, 2021, the Director issued notice of his intent to adopt an order declaring a set of classes of insurance coverage or risk eligible for export pursuant to Idaho Code § 41-1216(1). This notice requested interested parties provide comments to the Department by July 19, 2021.

The Department received one only comment, which was a request for an additional line, and after consideration, has forwarded the suggestion to the Surplus Lines Association for future review. The Department did not receive any comments that the proposed lines listed have an adequate market.

Therefore, IT IS ORDERED:

- 1. That there is no reasonable or adequate market among Idaho-authorized insurers either as to acceptance of the risk, contract terms, or premium or premium rates for the class or classes of insurance coverage or risk described in **Exhibit A**; and
- 2. That the classes of insurance coverage or risk described in **Exhibit A** are eligible for export in accordance with chapter 12, title 41, Idaho Code.
