STIPULATION

COMES NOW, the Idaho Department of Insurance (Department) by and through its undersigned counsel, Thomas A. Donovan, and Craig Sterling Hansen (Hansen) by and through his undersigned counsel, W. John Thiel, and stipulate and agree as follows:

The Department filed its Complaint and Notification of Rights in the above captioned matter on August 6, 2001. Hansen filed his Answer and Demand for Hearing on August 16, 2001. The Director has jurisdiction over the parties and subject matter.

The Respondent, CRAIG STERLING HANSEN (HANSEN), is a duly licensed resident insurance agent in the state of Idaho, holding agent license No. AG072533, and is therefore subject to the provisions of Title 41, Idaho Code, and to the rules of the Department promulgated thereunder.

As evidenced in the Order of the Court Deferring Further Proceedings dated May 16, 2003, pending in the 167th Judicial District Court of Travis County Texas, Case 09-74163, State of Texas v. Craig Hansen, Hansen pled guilty to the offense of "misapplication of fiduciary property, a second degree felony" on January 31, 2003. The court determined as of May 12, 2003, that further proceedings in the Travis County Criminal case would be deferred without entering an adjudication of guilt, and Hansen was placed on community supervision for a period of ten years including other conditions. Condition number twenty-five (25) provides that "(Hansen) is to not engage in the business of insurance."

Based on the pleadings in this matter and the Texas order, the parties agree that a fair, efficient and just resolution of the pending administrative action is that Hansen voluntarily surrender his producer license and present evidence of his discontinuance of work in the insurance business. In addition, Mr. Hansen agrees to relinquish and refrain from holding any officer or director positions with any licensed insurance entity.

The parties voluntarily waive their rights to a hearing and to present evidence on these matters, and further waive their rights to seek a petition for reconsideration and to file a petition for judicial review from entry of the attached order.
