STIPULATION CONCERNING VERIFIED COMPLAINT AND FINAL ORDER

The parties herein, namely the Idaho Department of Insurance (the "Department") and Grant R. Moses ("RESPONDENT"), resident producer under title 41 of the Idaho Code, holding License No. 1748, do hereby agree and stipulate as follows:

1. As a duly authorized resident producer in Idaho, RESPONDENT falls within the jurisdiction of the Director of the Idaho Department of Insurance ("Director") and title 41 of the Idaho Code.

2. On August 26, 2016, the Department did file and serve a Verified Complaint and Notice of Right to Hearing (hereinafter "Verified Complaint") on RESPONDENT.

STIPULATION CONCERNING VERIFIED COMPLAINT AND FINAL ORDER - Page 1

3. Said Verified Complaint alleged various violations of title 41, Idaho Code, against RESPONDENT arising out of RESPONDENT's failure to follow instructions to increase the autopay of his client's monthly premiums for his client's life insurance policy, the resulting cancellation of the policy, and RESPONDENT's failure to timely submit his client's application for reinstatement with accompanying check.

4. RESPONDENT hereby admits each of the allegations and violations as stated in the Verified Complaint.

5. RESPONDENT shall pay an administrative penalty in the amount of \$2,000.

6. The terms of this Stipulation Concerning Verified Complaint and Final Order ("Stipulation") are appropriate and proper under the circumstances referenced herein, and this Stipulation is a full and final settlement of the issues raised between them herein.

7. RESPONDENT enters into this Stipulation freely and voluntarily, after having had the opportunity to consult with his counsel, and with full understanding of the legal consequences of this Stipulation and the subsequent Final Order approving this Stipulation.

8. Upon execution of this Stipulation, no subsequent action or assertion shall be maintained or pursued in any manner asserting the invalidity of this Stipulation and Final Order approving its provisions.

9. RESPONDENT knowingly and voluntarily waives any rights he would otherwise have to litigate the matters and issues addressed herein, including but not limited to the rights afforded by Idaho Code § 41-232A, which provides for: the right to a hearing; the right to be represented at a hearing by counsel chosen and retained by Respondent; the right to present a defense, oral and documentary evidence and to cross-examine witnesses at such hearing; and the right to seek judicial review.

10. RESPONDENT understands that this Stipulation and the Final Order approving its STIPULATION CONCERNING VERIFIED COMPLAINT AND FINAL ORDER – Page 2 provisions shall be reported to the Regulatory Information Retrieval System ("RIRS") maintained by the National Association of Insurance Commissioners ("NAIC").

11. Upon the Director's entry of the Final Order approving this Stipulation, this Stipulation and the Final Order shall be a public record under the Idaho Public Records Act.

12. This Stipulation is subject to approval by the Director or the Director's designee, and shall become effective and binding upon the Department and RESPONDENT upon such approval. Should the Director decline to approve this Stipulation, the Department and RESPONDENT shall retain all of their rights, claims and/or defenses, and any factual and/or legal admissions made by RESPONDENT herein shall be withdrawn.

13. This Stipulation and Final Order embodies the entire agreement between the Department and RESPONDENT, and there are no agreements, understandings, representations or warranties that are not expressly set forth herein.
