The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order may appeal it by filing a petition for judicial review in the district court of the county in which: (1) the hearing was held; or (2) the final agency action was taken; or (3) the aggrieved party resides or operates its principal place of business in Idaho; or (4) the real property or personal property that was the subject of the agency decision is located. An appeal must be filed within twenty-eight (28) days of: (a) the service date of this final order, or (b) an order denying a petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review to the district court does not itself stay the effectiveness or enforcement of the order under appeal.

VERIFIED COMPLAINT AND NOTICE OF RIGHT TO HEARING

The Idaho Department of Insurance (hereinafter "Department"), by and through its attorney of record, David M. Farney, Deputy Attorney General, does hereby complain and allege as follows:

- 1. The Director of the Department has jurisdiction in the state of Idaho over matters involving insurance regulation and licensing, in accordance with title 41, Idaho Code.
- 2. This administrative proceeding is brought under the provisions of the Idaho Insurance Code, Idaho Code § 41-101 et seq., including, among other sections, Idaho Code § 41-

A

1016, which authorizes the Department to initiate a contested case against individuals licensed under the provisions of title 41, chapter 10, Idaho Code, including insurance producers, seeking revocation of the license, as well as the imposition of administrative penalties, if the Director of the Department finds that any one or more of the causes or violations set forth in subsections (1)(a) through -(n) of that section exist.

RESPONDENT

3. REGINALD ALFRED WHITELY (hereinafter "Respondent") is a resident of the state of California and holds Idaho Nonresident Producer License No. 591492, which license was originally issued on October 11, 2016.

FACTS AND ALLEGATIONS

- 4. The above paragraphs are incorporated herein as if set forth in full.
- 5. On or about October 6, 2016, Respondent made application for an Idaho nonresident producer license online at the National Insurance Producer Registry (NIPR) website.
- 6. Respondent submitted payment to NIPR for the application and transaction fees in the total sum of \$86.18 using an electronic check.
- 7. On October 11, 2016, the Department approved Respondent's application and issued Idaho Nonresident Producer License No. 591492 to Respondent.
- 8. On February 9, 2017, the Department was notified by NIPR that Respondent's payment via electronic check had not been honored by Respondent's bank and that the sum due for the application and transaction fee remained outstanding.
- 9. On February 9, 2017, the Department notified Respondent via a letter sent by U.S. Mail and by email of the outstanding amount owed to NIPR for the Idaho license application and transaction fee. The same letter also warned Respondent that if he failed to pay the outstanding

amount, the Department would seek to revoke his Idaho Nonresident Producer License No. 591492.

- 10. To date, Respondent has failed to pay the application and transaction fees due for his nonresident producer license.
- 11. Section 41-1007, Idaho Code, requires an applicant for an Idaho producer license to pay fees as prescribed by the Director pursuant to section 41-401, Idaho Code. Respondent's failure to pay the required fees is a violation of section 41-1007(1)(d), Idaho Code, giving the Department cause to seek revocation of Respondent's nonresident producer license and imposition of an administrative penalty pursuant to section 41-1016(1)(b), Idaho Code.
- 12. Respondent's failure to complete payment of the license fee as required by law demonstrates financial irresponsibility and is a violation of section 41-1016(1)(h), Idaho Code, giving the Department additional cause to seek revocation of Respondent's nonresident producer license and the imposition of an administrative penalty.

RELIEF REQUESTED

13. Based on the foregoing, and pursuant to Idaho Code § 41-1016(1)(b) and (h), the Department prays that the Director enter an order revoking Idaho Nonresident Producer License No. 591492 held by Respondent and imposing an administrative penalty of \$1,000 per violation alleged herein for a total penalty of Two Thousand Dollars (\$2,000).

NOTICE OF RIGHT TO A HEARING

Pursuant to Idaho Code § 41-232A, Respondent has the right to a hearing on this matter. In order to exercise this right, a written request for a hearing must be filed and served upon the Department within twenty-one (21) days after service of this Complaint. Failure to file and serve a written request for a hearing upon the Department within the 21-day time period shall be

deemed a waiver of the opportunity for a hearing and to contest the allegations in the Complaint, pursuant to Idaho Code § 41-232A(2).

Any written request for a hearing shall be served on the Director of the Idaho Department of Insurance, addressed as follows:
