**ORDER GRANTING MOTION and
ORDER SETTING ASIDE ORDERS
OF DEFAULT REVOKING IDAHO

On July 11, 2022, the Director of the Idaho Department of Insurance (“Director”) entered an *Order of Default Revoking Idaho Nonresident Producer License of Marcus Kent Maxfield*. On July 28, 2022, the Department entered a (*Corrected*) *Order of Default Revoking Idaho Nonresident Producer License of Marcus Kent Maxfield* (“Orders of Default”).

The Director having reviewed the foregoing and the requirements of Idaho § 41-232(5), finds that good cause exists to set aside the Orders of Default and continue and allow this matter to proceed on the merits.

Based on the foregoing and in consideration of the premises, and good cause appearing;

IT IS HEREBY ORDERED that the Department's *Motion to Set Aside Orders of Default Revoking Idaho Nonresident Producer License of Marcus Kent Maxfield* is GRANTED;

IT IS FURTHER ORDERED that the *Orders of Default Revoking Idaho Nonresident Producer License of Marcus Kent Maxfield* entered on July 11, 2022, and July 28, 2022, are VACATED and SET ASIDE; and,

IT IS FURTHER ORDERED that MARCUS KENT MAXFIELD shall forthwith provide the Department of Insurance with complete and current mailing addresses and contact information including his residential and business mailing addresses, in compliance with Idaho Code § 41-1008(6).


