SUMMARY ORDER REVOKING IDAHO NONRESIDENT INSURANCE PRODUCER LICENSE

The Director of the Idaho Department of Insurance ("Director") has received notice that, on June 17, 2022, the Commissioner of Securities and Insurance, Office of the Montana State Auditor ("Montana Commissioner") issued a *Consent Agreement and Final Order* suspending the resident insurance producer license of Kevin Patrick Johnson ("Johnson"), effective immediately, until Johnson pays a fine as imposed by agreement and order. Upon reviewing the *Consent Agreement and Final Order*, and pursuant to Idaho Code § 41-1016(2)(a), the Director enters this Summary Order Revoking Johnson's Idaho Nonresident Producer License No. 607547.

## FINDINGS OF FACT

- 1. Johnson, at all times relevant hereto, was licensed in his home state of Montana as a resident insurance producer holding license number 1514811.
- 2. On November 4, 2021, Johnson and the Montana Commissioner entered into a Consent Agreement wherein Johnson agreed to pay one individual and two entities restitution totaling \$25,000 under a payment plan, with payments to begin on January 15, 2022. On November 10, 2021,

the Montana Commissioner entered the Final Order adopting the Consent Agreement.

3. Johnson violated the November 10, 2021 Final Order by failing to make payments as outlined in the November 4, 2021 Consent Agreement.

4. On June 3, 2022, the parties entered a second Consent Agreement. In it, the parties stipulated that: (1) Johnson had violated Montana Law by not complying with and breaching the first Final Order and Consent Agreement; (2) that Johnson will make the required number and amounts of payments agreed to in the first Consent Agreement under a payment plan to start on October 1, 2022; and (3) that Johnson's insurance producer license shall be suspended until the Montana Department of Insurance receives the first fine payment from Johnson, which is due on October 1, 2022. The Montana Commissioner entered a Final Order adopting the second Consent Agreement on June 17, 2022.

5. Johnson has been licensed as an Idaho nonresident insurance producer under license number 607547 since its issuance on February 28, 2017.

#### **CONCLUSIONS OF LAW**

4. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, suspend for not more than 12 months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation, or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state.

5.	The Director finds these circumstances justify revoking Johnson's Idaho Nonresident
Insurance P	roducer License, pursuant to Idaho Code § 41-1016(2)(a).

### **NOTIFICATION OF RIGHTS**

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Any such motion for reconsideration shall be served on the Director of the Idaho Department of Insurance, addressed as follows:

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
