**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT PUBLIC
ADJUSTER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order wherein the Utah Insurance Commissioner (“Commissioner”) ordered Matthew Jenson’s (“Jenson”) license surrendered in the state of Utah. For the reasons discussed below, the Director enters this Summary Order Revoking Jenson’s Idaho Nonresident Public Adjuster License No. 16727838.

FINDINGS OF FACT

1. On July 10, 2018, Jenson was licensed in his home state of Utah as a resident public adjuster under License No. 676840.
2. On May 23, 2023, the Commissioner entered a final *Stipulated Findings of Fact, Conclusions of Law and Order* (the “Order”) which ordered Jenson’s resident public adjuster license surrendered in lieu of administrative action. Jenson may not apply for any Utah insurance license for five years from the date of the Order.
3. Jenson has been licensed as an Idaho nonresident public adjuster since July 8, 2020.

CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(b)(i), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if a nonresident no longer has a license in the licensee's home state because the home state license was voluntarily surrendered for any reason except relicensing as a resident in another state.

2. These circumstances justify revoking Jenson's Idaho Nonresident Public Adjuster License under Idaho Code § 41-1016(2)(b)(i).

ORDER

NOW, THEREFORE, IT IS ORDERED that Jenson's Idaho Nonresident Public Adjuster License is REVOKED, effective immediately.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. *See* Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
