<b>Nature of Hearing:</b>	The plan of reorganization of Farm Bureau Mutual Insurance Company of Idaho, and its intent to form a mutual insurance holding company in accordance with title 41, chapter 38, Idaho Code.
<b>Issues Involved:</b>	Whether the interests of the policyholders of Farm Bureau Mutual Insurance Company of Idaho are properly protected and whether the plan of reorganization as proposed is fair and equitable to its policyholders.
