STIPULATION AND ORDER


STIPULATION

COME NOW the Department of Insurance, State of Idaho (Department), by and through its counsel, Thomas A. Donovan, Deputy Attorney General, and AMY R. MALLETT, (MALLETT) and hereby stipulate and agree as follows:

1. MALLETT is duly licensed as a resident producer by the State of Idaho, holding resident producer license AB108190 and is therefore subject to the provisions of Title 41, Idaho Code, and to the Rules and Regulations of the Department of Insurance promulgated thereunder.

2. On September 27, 2007 the Department received a termination for cause notice regarding MALLETT from U.S. Bancorp Investments, Inc. dated September 25, 2007.
3. MALLETT admits to a violation of Idaho Code § 41-1016(1)(h).
4. MALLETT agrees to the revocation of her producer license No. AB108190.
5. MALLETT will promptly return her license No. AB108190 to the Idaho Department of Insurance pursuant to Idaho Code § 41-1027.
6. The parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein, that they enter into this Stipulation in lieu of and to avoid a contested hearing, and that they have entered into this Stipulation knowingly, voluntarily, and with full knowledge of any rights they may be waiving thereby including the right to a hearing. Additionally, the parties hereby waive the right to seek reconsideration and judicial review of the attached order.


