**STIPULATION AND
ORDER**

The parties, individually or by and through their respective attorneys, do hereby agree and stipulate as follows:

1. That Duane C. Bogar does admit to the allegations as set forth in the *Complaint and Notification of Rights* filed with the Director on April 3, 2007, and served upon the Producer on the same day;
2. That the Director, upon review of all the facts and circumstances, including but not limited to the fact that Duane C. Bogar admitted to the violations, promptly replied,

and that there is a sound basis to believe there will be no further violations, that it would be appropriate to impose an administrative penalty;

3. That the Idaho Department of Insurance shall maintain a close vigil on this matter now and into the future.
4. That based upon the foregoing, the parties hereto agree a copy of this *Stipulation and Order* will be placed in Duane C. Bogar's permanent record at the Idaho Department of Insurance, that an administrative penalty of Three Hundred Dollars (\$300.00) shall be imposed upon Duane C Bogar, and that upon payment of said penalty in full, this matter shall be dismissed with prejudice.

ORDER


