


within the jurisdiction of the Director of the Idaho Department of Insurance and Title 41 of the Idaho Code;

2. ROTHMAN is a licensed producer, holding license number AB087273 since September 17, 2001 and, therefore, ROTHMAN falls within the jurisdiction of the Director of the Idaho Department of Insurance (Department) and Title 41 of the Idaho Code;
3. ROTHMAN was originally issued a producers license for disability lines on September 17, 2001;
4. ROTHMAN applied for licensing under the lines of casualty, life, property and variable contract lines by submitting a Uniform Application for Individual Insurance Producer License dated July 5, 2005 and received by the Department on July 11, 2005. The Department added the lines on July 13, 2005;
5. On or about April 13, 2005, C.M. MEIERS and ROTHMAN transacted insurance by accepting an application and submitting for coverage under a surplus line property and casualty insurance policy;
6. C.M. MEIERS and ROTHMAN agree to admit to violations of Idaho Code § 41-1004(1) for accepting and placing insurance business without being licensed in Idaho for the kind of insurance involved;
7. C.M. MEIERS and ROTHMAN agree to limit any future transactions to include lines for which they are licensed in Idaho;


8. C.M. MEIERS and ROTHMAN agree to pay, jointly and severally, a settlement fee of one thousand (\$1,000) dollars, payable within thirty (30) days of the entry of this Stipulation and Order;
9. The Department agrees to forego administrative action against C.M. MEIERS and ROTHMAN in regard to the Mag Business Solutions, Inc. matter; and
10. The parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein, and that they have entered into this Stipulation knowingly, voluntarily, and with full knowledge of any rights they may be waiving thereby. Additionally, the parties hereby waive the right to seek reconsideration and judicial review of the attached order.
