The parties to the above-entitled matter, namely Transaction Applications Group, Inc., a foreign corporation, and the Director of the Idaho Department of Insurance, do hereby enter this stipulation and agree as follows:


1. That the Director has the authority to issue licenses and to regulate third party administrators within the State of Idaho that includes Transactions Application Group, Inc., operating under an expired certificate of registration no. 61813. The certificate expired on January 1, 2009.

2. That Transaction Applications Group, Inc., a foreign corporation, has operated within the State of Idaho and has acted as, and held itself out to be, a third party administrator as defined in Chapter 9, Title 412, Idaho Code without holding a valid and current certificate of registration as required under Idaho Code Section 41-913.
3. That as of June 15, 2009, the Respondent filed an Application for Administrators Certificate of Registration within the Director of the Idaho Department of Insurance.
4. That the Respondent admits that it is in violation of Idaho Code Section 41-913 and that an appropriate sanction should be entered.
5. That the Respondent, its principals, its officers, its board of directors, and its successors-in-interest shall not operate the Respondent or any other entity under their control, custody, or ownership as an administrator as defined under Title 41, Chapter 9, Idaho Code, without first submitting an application for, and holding a valid, certificate of registration from the Director of the Idaho Department of Insurance pursuant to Idaho Code § 41-913 or its subsequent equivalent.
6. That as a result of this violation and in consideration of Respondent's admission herein and stipulation not to operate without a valid certificate of registration, the Director of the Department of Insurance will impose a penalty in the amount of Five Hundred Dollars (\$500.00).
7. The Respondent herein specifically waives any right to hearing, to reconsideration, or for further judicial review of the controversy in question.
8. IT IS SO AGREED






