**STIPULATION AND ORDER**

The parties to the above-entitled matter, namely Raymond F. Snyder [Snyder], nonresident producer license no. 50905, Snyder Insurance Services, Inc. [Snyder Insurance Services], a foreign corporation, nonresident producer firm license no. 82367 [collectively "Respondents"], and the Director of the Idaho Department of Insurance [Director], do hereby enter this stipulation and agree as follows:


1. That the Director has the authority to issue licenses and to regulate producers and firms within the State of Idaho pursuant to Idaho Code § 41-101 *et seq.* That said authority extends to nonresident producers and firms, including Respondents.

2. That on six separate occasions, Respondents placed certain risks that were formerly with an Idaho-admitted and authorized insurers with non-admitted unauthorized insurers in a manner contrary to Idaho Code § 41-1214.
3. Respondents admit to violating Idaho Code § 41-1214 on six separate occasions.
4. That hereafter Respondents promise not to operate their business in a manner that violates Idaho's surplus lines law, including but not limited to Idaho Code § 41-1214 by placement of an Idaho risk with a non-admitted carrier in a manner inconsistent with law.
5. That as a result of the violations and in consideration of Respondents' admission herein and stipulation hereto, the Director will not seek revocation of the licenses identified hereinabove for the admitted violations; and will only impose a penalty in the amount of Five Hundred Dollars (\$500.00) for each of the six violations for a total of Three Thousand Dollars (\$3,000.00).
6. The Respondents herein specifically waive any right to hearing, to reconsideration, or for further judicial review of the controversy in question.
7. IT IS SO AGREED




